Ottawa, March 17.—(Special)—When the House opened this afternoon it was observed that most of the members were wearing smocks in their button holes, in honor of St. Patrick's Day. A great bunch of the Irish emblem rested upon the desk of Hon. John Costigan, to whom it had been sent by a friend.

It has been a fighting day in the House, and it was characterized by some able, not by some bitter, speeches.

Sir C. H. Tupper resumed the debate on the Remedial Bill, and quickly got after Clarke Wallace and Dalton McCarthy. He said that Mr. Wallace became a member of the Government and from time to time as such heard the solemn declaration of Sir John Thompson that the Government, in dealing with this question, would be guided by the decision of the Privy Council, whether that decision was for or against the rights of the Catholic minority. The Government, he said, had taken part in the decision given in January, 1895, and yet Mr. Wallace dared to remain a member of the Government for the month of November, 1895, when he resigned.
