Mr. Morgan Wood Points Them to the Catholics for a Lesson.

Dixon, County Chaplain, read Psalms 10 and 20, the congregation reciting alternate verses. After the inspiring hymn, "Onward Christian Soldiers," and a short scripture reading, the pastor asked for a liberal collection on behalf of the order in aid of the Orphan Asylum, and the True Blue Orphanage Fund, which he hoped would be responded to by all present without much solicitation, as he "required from my own congregation."

While the collection was in progress several members of the choir rendered delightful solos under the direction of the organist and choristman, Mr. A. B. Jury.

In commenting the sermon, Rev. Morgan Wood stated that he was much surprised at being asked to preach to the Orange Order, as he was not a member himself "on the inside, but I am on the outside."

He then took his text from St. Matthew viii, 23, "For one is your Master, even Christ, and all ye are brethren." In the course of the sermon Mr. Wood spoke of the great Empire to which we belong and anticipated glorious results from the Anglo-American alliance.

Speaking of Orangemen, he said that the order was the ambition of some of its junior associations to fight or put down the Catholics. This, he said, was a very bad thing, and he said, "for no better lesson can be taught the members of the Orange Order than to take as an example the Roman Catholic girl who goes to mass at 6 o'clock every Sunday morning, when my people can't get here at 11."

After the hearty singing of the National Anthem and the presentation of the banner to the members and all dispersed, the hands playing harmoniously.

Dr. Britton cautioned the members against appealing to the legislature, as that would probably not take any action; the motion was a blow at Toronto, the Western and Queen's Universities, and should be thrown out.

Former arguments, which have been extensively reported, were repeated. Dean Gellie pointed out that as the Legislature provided for the seats of those against the motion, this aimed, the Council could do nothing. "A miserable rump of a council this would be if the educational institutions were left out," he said.

"The motion is a gratuitous insult to Dr. Gellie, Giffin, Foster and Thorburn," said Dr. Foster also gave reasons why his school, the University of Toronto, should continue to be represented, and an amendment of Dr. Brock's, that the resolution be referred to the council, was carried by 10 to 7.
