

Of the Municipality of the Township of *Elgin*; praying that the Village of *Beauharnois* may not be the chief place of the Judicial District of *Beauharnois*.

Of the Municipality of the Township of *Elgin*; praying that the Office of School Inspectors in *Lower Canada* may be abolished.

Of the Municipality of the Township of *Elgin*; praying that the Costs on small sums be restricted in the Circuit Courts to the Tariff of the Commissioners' Court.

Of the Municipality of the Township of *Elgin*; praying for the passing of a Bill to prevent the manufacture and importation of Spirituous Liquors in this Province.

Of the Municipal Council of the County of *Ontario*; praying for the passing of an Act to legalize and establish certain By-laws passed by the late Home District Council for the establishment of Roads throughout the said County.

Of the Reverend *M. Duguay* and others, of the Parish of *Ste. Flavie*; praying for aid to open out a Road through the Township of *Flavie*, and also for a Wharf.

Of the Municipality of the Parish of *St. Simon*; praying aid for a Model School in the said Parish.

Of *Rieule Boulliane* and others, of the Townships of *Tadousac* and *Bergeronme*, County of *Saguenay*; praying for the passing of an Act for the protection of the Salmon and Salmon Trout Fisheries in the River *St. Lawrence* and its tributaries.

Of the Municipal Council of the County of *Wentworth*; praying that Municipalities entitled to a share of the Clergy Reserves Fund, may be allowed to invest the same in Real Property, the interest thereof annually to be applied to the support of Elementary Education within each Municipality.

Of *Richard Duncan Fraser*, of *Fraserfield*, *Edwardsburg*; praying to be indemnified for services rendered during the War of 1812.

Of *Marcel Bolduc* and others, of the Parish of *St. Urbain*, County of *Charlevoix*; praying for aid to reconstruct a Bridge over the *River du Gouffre*, in the said Parish.

Of the Municipal Council of the County of *Ottawa*; praying that Roads may be opened from the *Ottawa* River along the Valleys of the *Gatineau*, *Lièvre* and *Petite Nation* Rivers, as far north as the parallel latitude of *Quebec*, and also that free grants may be made to actual settlers on the said Roads.

Of the *St. John's* Library Association, County of *St. John's*; praying for aid.

Of *Joseph Pothier*; praying for arrears of pension due him for services during the War of 1812.

Of the Mechanics' Institute and Library Association of the Village of *St. Ours*, County of *Richelieu*; praying for aid.

Of *John Waldie* and others, of *Wellington Square*, in the County of *Halton*; and of the *Montreal* Young Men's Christian Association; praying for the passing of a Law for the better observance of the Sabbath day.

Of the *Montreal St. Patrick's* Orphan Asylum; praying for amendments to their Act of Incorporation.

Of the Mechanics' Institute of the Village of *Streetsville*, County of *Peel*; praying for aid.

Of the *Montreal* Home and School of Industry; praying for aid.
