EFFECT OF LOW WATER LEVEL IN GEORGIAN BAY AND LAKE HURON

**Mr. John Loney (Bruce):** Mr. Speaker, I have a question for the Minister of Transport. Will the minister give immediate consideration to the communication he has received from the Georgian bay development association with regard to the current low water levels in the lake Huron and Georgian bay area?

**Hon. J. W. Pickersgill (Minister of Transport):** Mr. Speaker, apparently this is a much more urgent matter than the matter of getting freight to Newfoundland, but I am glad to tell the hon. gentleman that I have been giving urgent consideration to this matter for many months.

**Mr. Knowles:** Mr. Speaker, on a point of order, I object to the slur that was just cast on the Chair.

**Mr. Churchill:** Mr. Speaker, I wonder whether the minister would withdraw this slur on the Chair.
