MUNICIPAL DEVELOPMENT LOAN FUND-USE OF UNALLOTTED AMOUNTS

Douglas (Eurnaby-Coquitlam): Mr. Speaker, perhaps I can get the Minister of Finance to shed his veil of silence by asking him a question with respect to the municipal development and loan fund legislation regarding which he made an announcement this afternoon. Could the Minister tell the House whether all the funds which were voted by Parliament are likely to be used up? If they are not completely depleted in all the provinces, is there any possibility that whatever is left could be allocated to the provinces which have already reached their maximum allocation but still have applications on hand?

Hon. Walter L. Gordon (Minister of Finance): Mr. Speaker, it is difficult to say categorically that the funds allocated to every province will be used up to the extent of the full 100 per cent, because it is too soon; this program has another nine months to run. Therefore, as I cannot forecast this particular matter, I think it would be inappropriate for me to indulge in speculation.

In some cases, I think in most cases, the provinces felt that only they were in a position to determine whether it was wise for a particular municipality to be granted a loan for a particular purpose. To suggest that the Federal Government should interfere in this arrangement which has worked very satisfactorily would not, I think, be a wise suggestion to accept.

> Mr. Douglas: A supplementary question. Surely the Minister is aware that I did not suggest interference. I asked the Minister whether the Government was prepared to consider providing additional funds to cover applications which were already on hand to be processed in those provinces where the funds which were allocated have been depleted.

> Mr. Gordon: I apologize if I misunderstood my hon. friend's question. The processing of these applications is a matter for the provinces. They have held some of them up, presumably intentionally. They knew how much money was available for the municipalities in their provinces and they proceeded to allocate it as they thought best.
