SKI SAFETY MEASURES IN NATIONAL PARKS

Question No. 938-Mr. Lambert:

- 1. Among the regulations of the national parks branch of the Department of Northern Affairs and National Resources, are there requirements for first aid and medical facilities at the site of various skiing developments in the Banff and Jasper national parks?
- 2. If so, what are such requirements?
- 3. Do these regulations call for qualified medical practitioners to be on duty or readily available especially on week ends?
- 4. If not, is consideration being given to this and other related safety measures on ski slopes in the national parks?

Hon. Arthur Laing (Minister of Northern Affairs and National Resources): 1. No.

- 4. This department has always provided for the safety of skiers in the parks. For many years ski patrols have been maintained in developed ski areas for the purpose of providing first aid and evacuation of injured skiers. Ski patrol personnel are thoroughly trained and highly qualified to perform the duties required of them.

Adequate telephone or radio communication systems exist between ski development areas and visitor services centres where medical practioners, hospital and ambulance services are available. Our present policy calls for ski patrol, first aid and evacuation services to become the responsibility of the ski area operators. The department will continue to set standards for these facilities and services.
