Inquiries of the Ministry

Mr. Speaker: Order, please. If that is the only thing the hon. member wishes to ask, his first question is unacceptable.

Mr. Groos: Then may I rephrase my question and ask the minister whether there is any doubt that the closure of salmon fishing in area 19 and part of area 20 in the straits of Juan de Fuca is still in fact to take place, in view of the representations he has received from the commercial, sports and wildlife preservation societies in British Columbia?

Hon. H.-J. Robichaud (Minister of Fisheries): Yes, Mr. Speaker, I did receive a telegram from the sports organization claiming that the closure of the areas mentioned does not go far enough. I also received a telegram from the fisheries association stating that it is going too far, so I can say there is a conflict between the two groups. The matter is under consideration at the present time.

Mr. G. L. Chatterton (Esquimalt-Saanich): I should like to direct a question to the Minister of Fisheries apropos the question asked by the hon. member for Victoria (B.C.) with regard to the apparent conflict between net fishermen, troll fishermen and sports fishermen. Will the minister refer this matter to the fisheries committee so they may go out to the Pacific coast and hear evidence from these groups with a view to finding an equitable division of the resources?

CANADIAN CENTENNIAL

INVITATION TO U.S. PRESIDENT TO ATTEND CEREMONIES IN OTTAWA

On the orders of the day:

Mr. Barry Mather (New Westminster): Mr. Speaker, if I may I should like to address a question to the Prime Minister. Can the Prime Minister say whether his attention has been called to news reports to the effect that President Johnson of the United States has so far failed to acknowledge Canada's invitation to him to attend centennial ceremonies in the national capital? If these reports have been drawn to the attention of the Prime Minister, does he propose to make a statement on this matter?

Right Hon. L. B. Pearson (Prime Minister): Mr. Speaker, the President has indeed acknowledged our invitation and has expressed the hope and expectation of visiting Canada and Expo during our centennial year. Two dates were put forward. One was the latter part of May—I think it was May 25 that he would arrive—and I think the other was toward the end of July or August. I have not the exact dates in mind. It had been hoped he would be able to accept the earlier date, but I understand that is not now possible and we expect him to be here on the later date.

MARITIME PROVINCES—INQUIRY AS TO LEGISLATION
