AIR TRANSPORT

MERGER BETWEEN AIR CANADA AND CANADIAN PACIFIC AIRLINES

Mr. W. B. Nesbitt (Oxford): I have a question for the Minister of Transport. Is the government planning a merger between Air Canada and Canadian Pacific Airlines? I ask this question, Mr. Speaker, in view of the recent suggestions by Air Canada advocating such a proposal.

Hon. Paul Hellyer (Minister of Transport): Mr. Speaker, the government is studying the whole question related to air policy, and the future corporate structure of Air Canada, in a general sense. I think I indicated some weeks or months ago in answer to a question that this suggestion which has been made is not a matter of urgent study. It is not the subject of a specific task force or anything of that nature. Nevertheless I think one has to look in a methodical way at the future of Air Canada and its corporate structure, financing and all related aspects, and then in due course perhaps to make some conclusions or recommendations which could be considered by the government. The chairman of Air Canada was stating a personal view I understand; he was not flying a kite for the government. This is one point of view. If the President of Canadian Pacific Airlines had been speaking he might have put forth a different view.
