REVENUE FOR FUTURE INCOME TAXES AS REPORTED BY CORPORATIONS IN CANADA

Question No. 187-Mr. Orlikow:

What reserves for future income taxes have corporations set aside since 1968 as reported to the Department of National Revenue or Statistics Canada and shown up to 1968 in their reports on Corporation Financial Statistics?

Mr. Gaston Clermont (Parliamentary Secretary to Minister of Industry, Trade and Commerce): The reserve for future income taxes as reported by corporations in Canada (excluding insurance carriers, co-operatives, crown corporations and tax exempt corporations) and as defined in "Corporation Financial Statistics" for years 1968 to 1971, the latest year available, were as follows:

Question No. 305-Mr. Whittaker:

- 1. What is the estimated number of companies or industries in the constituency of Okanagan Boundary?
- 2. What is the approximate division of this investment capital?
- 3. (a) In what areas is the foreign investment (b) what are the estimated amounts of these investments?
- 4. How do these figures compare (a) with those 1968 to 1974 inclusive (b) to that of surrounding areas in British Columbia?
- Mr. Gaston Clermont (Parliamentary Secretary to Minister of Industry, Trade and Commerce): Statistics Canada reports that: 1. The estimate of manufacturing establishments in the constituency of Okanagan Boundary in 1971 (the latest year for which data are available) is 170, as compared to 3,302 for the province of British Columbia.
- 2, 3 and 4. Statistics Canada cannot provide answers to these questions as immense quantities of time would be required to provide this information which is not readily available. Moreover, prior to 1971, British Columbia district boundaries, which are used as coding boundaries for statistical records, do not match well with the electoral district of Okanagan Boundary and therefore it would be difficult to make an estimate of manufacturing establishments prior to 1971 within the electoral district.

- 2. Has the government announced a phase-out of this consumer milk subsidy and, if so (a) on what date did the proposed phase-out begin (b) on what date will it conclude?
- 3. (a) Was the Government of Nova Scotia informed of the proposed phase-out of the subsidy and, if so, on what date (b) did the government receive complaints from the Government of Nova Scotia, through any of its ministries, against the proposed government phase-out of the subsidy and, if so (i) on what date or dates were such complaints directed to the government (ii) by whom (iii) in what form?
- 4. Were any complaints against the proposed phase-out of the consumer milk subsidy directed to the Minister of Agriculture by the Nova Scotia Minister of Agriculture and Marketing at the federal-provincial conference of Agriculture Ministers held in Winnipeg, Manitoba?
- Hon. E. F. Whelan (Minister of Agriculture): 1. (a) October 1, 1973. (b) Five cents per quart on fluid milk; 20 cents per pound on skim milk powder. (c) One year.
- 2. A phase-out of the fluid milk portion of the subsidy has been announced. The subsidy on skim milk powder has been increased by four cents per pound and will continue. (a) October 1, 1974. (b) December 31, 1974.
- 3. (a) Yes, August 15, 1974. (b) Yes. (i) September 9, 1974 (ii) T. A. Murray, Secretary, Manager, Nova Scotia Dairy Commission (iii) Telex.
- 4. At the time of the Conference, no announcement had been made in respect of the phase-out of the subsidy.
