In view of the exasperation and indignation of Canadians created by the method of imposing the 10 cents per gallon gasoline tax, increasing the cash flow requirements of bulk dealers, retailers and consumers, I move, seconded by the hon. member for Peace River (Mr. Baldwin):

That the House of Commons request the Minister of National Revenue to place a moratorium on this gasoline tax until the issue has been fully debated or until such time as a more acceptable method of administering it is instituted.
