## Oral Questions

I indicated publicly after the last report that I would designate a senior committee of senior Deputy Ministers, which I did, to prepare amendments to the Official Languages Act in order to ensure that vital piece of legislation was strengthened and enhanced and adapted to new conditions and requirements. That has been done.

The work is now at a senior ministerial level. It will go to Cabinet and will be introduced in the House at the appropriate time, and it will be of benefit to the country.

### GOVERNMENT POSITION

Hon. Warren Allmand (Notre-Dame-de-Grâce—Lachine East): Mr. Speaker, the Commissioner said there were some immediate problems to deal with, and I quote again: "Are we to suppose the Government can't walk and chew gum at the same time?" How and when is the Government going to deal with the Commissioner's criticism against CNR, Petro-Canada, Agriculture Canada, CMHC, the Prime Minister's Office, National Defence, Correctional Services of Canada—and I could go on and on? When is the Government going to deal with these criticisms in the report?

Right Hon. Brian Mulroney (Prime Minister): Mr. Speaker, while we will work very, very effectively to protect and promote the interests of minorities, the English-speaking minorities in Quebec and the French-speaking minorities across the country, with enthusiasm and vigour, I can assure the hon. gentleman that I have no apologies to make to anyone about my stand and the stand of this Government in regard to protecting linguistic rights.

HANNA SHOE COMPANY IN SHAWINIGAN—GOVERNMENT POSITION

#### **CANADA POST CORPORATION**

CLOSURE OF ST. LAWRENCE SEAWAY POST OFFICE

Mr. Joe Reid (St. Catharines): Mr. Speaker, my question is directed to the Minister responsible in this House for Canada Post operations. Canada Post seems to continue to act as though service to the public is a secondary consideration. Is the Minister aware of the closing of the only post office which for 20 years has served the seamen and users of the St. Lawrence Seaway? What can be done to restore that service?

Hon. Michel Côté (Minister of Consumer and Corporate Affairs and Canada Post): Yes, Mr. Speaker, I am aware of the closing of that post office. Unfortunately, we had to close it for different reasons, mainly because it was a seasonal office and had a very limited clientele. To achieve important savings we had to close that post office. However, I can assure my colleague that we are looking for a convenient alternative to accommodate the sailors.
