



NEW TRIAL FOR BECKER ASKED FOR IN NEW YORK New York, Feb. 25—A motion for a new trial for Charles Becker, a former police lieutenant, convicted for the murder of Herman Rosenthal, was made in the supreme court today. Becker's counsel told the court that he had based his motion on newly dis-covered evidence that one of the state's witnesses to a material fact had testi-fied falsely at Becker's second trial. Attached to the papers was an affi-davit of James Marshall, made in Phila-delphia recently in which Marshall re-pudiated a part of his testimony at the second trial.
