Clerks, &c., referred, 269. Bill considered and amended; Reported, 338. Amendments agreed to, 409. Motions to re-commit Bill negatived; Passed, 420. By the Senate, 429. R. A., 436. (36 Vic., c. 28.)

- 2. House resolves to go into committee, to consider of providing for the payment of Judges, Clerks and Witnesses engaged in the trial of Election Petitions under the foregoing Bill, 246. Considered; Report 6 Resolutions; Referred to Committee on the Bill, 268. See *supra*, 1.
- 3. Mr. Speaker states that his Warrant for the appointment of Members to serve on the General Committee of Elections is on the Table, 48. Motion that under the provisions of the Statute, the Warrant should have been laid on the Table, on the 19th inst., instead of the 20th.,—and it is therefore not a Warrant, within the meaning of the Statute, Negatived, 68. Members sworn; Time of meeting appointed; All Election Petitions referred, and the corrected list of Members to serve on Election Committees, 74. Report Chairmen's Panel, 109. Amended Panels, 175, 195, 227, 234, 243, 274. Report Members' Panels; Their order decided by lot, 109. Amended Panels, 196, 274. Report the days appointed for choosing Election Committees, 115, 195. Report names of Members of Election Committees, 174, 235, 286.
- 4. The Chairman of the General Committee of Elections, having reported the names of Members chosen on certain Election Committees, subsequently states that no quorum of the General Committee had been in attendance that day, and he obtains leave to withdraw the Reports, 293. The same Report presented on a subsequent day, 310.
- 5. A Member of the Chairmen's Panel reports their selection of Chairmen for three Committees, but that doubts having arisen as to the legality of the election in consequence of the absence of some of the Members, they had subsequently met and unanimously elected the same gentlemen as Chairmen, 301.
- 6. An Election Petition presented on the fifteenth day of the Session (including the day on which the Speaker was chosen); Motion that it be received; Objection taken, on the ground that it was not presented within the first fourteen days; Mr. Speaker gives it as his opinion that as no other business could be done on the day of the election of Speaker, it was not until the following day that Parliament was formally opened; Question for reception of petition negatived, 58.
- 7. A Special Return dealt with by the House, and one of the candidates seated, (leaving to the opposing candidate the right of petition), 10. See *infra*, 48.
- 8. Motion to amend a certain Return, on the ground that the candidate returned had a minority of votes; Amended by referring the Return to the Committee on Privileges and Elections, 6. Report that the case should be disposed of under the Controverted Election Act, 32. See *infra*, 55.
- 9. Recognizances on certain Election Petitions (or securities offered in lieu thereof) reported unobjectionable, 99, 132, 165, 173, 180, 243.—Reported objectionable,—By Mr. Speaker, 131, 165, 180, 242.—By an Election Committee, 229.—A petition rejected by the House, on the ground that there is no Recognizance, 20. See infra, 60.
- 10. Objection taken to an alleged defect in Mr. Speaker's certificate of Recognizance; Objection overruled, 44.
  - 11. Mr. Speaker informs the House that the Sitting Member's objections to the
