ADMINISTRATOR YUKON TERRITORY. Mr. KYTE:

- 3. How much has he received for each since the date of his appointment?

Mr. ROCHE:

1. G. N. Williams.

- 2. First appointed 9th October, 1915, acting until 9th June, 1916. Re-appointed 13th October, 1916, and is still acting. Salary, \$500 per month. He does not receive any living allowance.
- 3. From 9th October, 1915, to 9th June, 1916, \$4,020.97. From 13th October, 1916, to 31st July, 1917, \$4,806.45. Total, \$8,827.42.

MARCONI STATION AT LOUISBURG.

Mr. KYTE:

- 1. Has Marconi wireless station at Louisburg, N.S., been closed, and, if so, at what date?
- 2. Are the censors who were stationed there employed anywhere else, and if not, do they still receive their salary as censors?

3. Is it the intention of the Department of Militia to keep at that wireless station the sol-

Sir EDWARD KEMP:

- 1. On 4th August, 1917, the Marconi Wireless Telegraph Company was ordered to cease to transmit traffic.
- 2. The services of the present censorship staff will be dispensed with on the 1st September, when the office will be abolished. The censors will receive pay during this time (4th August to 1st September), as their services are necessary in winding up the business.
