#### FUEL SUPPLY

# Mr. MICHAUD:

Is it the intention of the Government to try and secure fuel supply for Canada independent of the United States?

Hon. Mr. STEWART: No steps are being taken to import fuel as a government undertaking either from the United States or elsewhere; but investigations are being carried on further to develop our domestic fuel resources especially in those parts of the country where fuel shortages occur with a view to reducing the amount of fuel imported. It would appear also that some steps are being taken by private interests in Great Britain to secure a permanent place in the Canadian market for domestic coal.

### MECHANICS

## Mr. MICHAUD:

Is the Government aware as to whether or not Canada is in need of more mechanics?

Hon. Mr. MURDOCK: Information reaching the Department of Labour does not suggest the need of more mechanics for the Dominion at large. Local difficulties occasionally arise and these are frequently met through the agency of the Employment Service, by obtaining workmen found unemployed in other localities. The situation necessarily varies from day to day, and it may be found impossible in a particular case to meet in this way a demand for highly skilled workmen in a particular craft.

#### MONCTON AND BUCTOUCHE RAILWAY

### Mr. HANSON:

1. Has the purchase price of the Moncton and Buctouche Railway been paid by the Government?

2. If not, what is the cause of the delay?

Is it the intention of the Government to see that the creditors of the said railway company are paid in full before anything is paid to the railway company?

3. 80 pounds per yard.

4. No; as a result of representations made to Sir Henry Thornton, when in the West recently, it was decided to let matter stand pending further consideration.
