UNEMPLOYMENT ASSISTANCE

PROVISION FOR FEDERAL CONTRIBUTIONS TO COSTS
IN PROVINCES

Hon. W. E. Harris (for the Minister of National Health and Welfare) moved that the house go into committee at the next sitting to consider the following resolution, which has been recommended to the house by His Excellency:

That it is expedient to introduce a measure to provide for contributions by Canada, to be paid out of the consolidated revenue fund, in respect of unemployment assistance costs in the provinces.

STARRED QUESTIONS

BANK HOLD-UP, COQUITLAM, B.C.

Question No. 47-Mr. Goode:

Have steps been taken by the government to give official recognition to R.C.M.P. corporal Johnstone and the officers and men of the Burnaby, Maillardville and Coquitlam detachments of the R.C.M.P., in British Columbia, for their bravery and attention to duty in thwarting an attempted hold-up at the Royal Bank of Canada, Coquitlam, British Columbia?

WAR VETERANS' ALLOWANCE

Question No. 49-Mr. Knowles:

1. Has the government, at any time since July 28, 1955, given consideration to proposing an amendment to the War Veterans Allowance Act so as to prevent the amount of the allowance drawn by a recipient thereof from being reduced by virtue of the receipt of the pension under the Old Age Security Act?

2. If so, what is the result of such consideration?
3. If not, is the matter now under consideration?

Hon. Hugues Lapointe (Minister of Veterans Affairs): Mr. Speaker, in answer to this question I wish to tell my hon. friend that the government always has under consideration all legislation pertaining to veterans' affairs.

As regards the particular amendment suggested by the hon, member in his question, as the hon, member knows, this matter has been discussed many times before this house on the estimates; it has been discussed before

various parliamentary committees on veterans' affairs and also on the special committee on estimates last year.

As recently as July 18, 1955, I made a statement on the subject, which appears on page 6333 of *Hansard*. This statement still reflects the thinking of the government on this matter.

- 4. What tariff duties are applied by the United States thereon?
