Some has occurred, but there has been such interest created in the United Kingdom with regard to expanding their trade with Canada that I think we will see excellent results flowing from the work of the mission.

Mr. Chevrier: May I ask a supplementary question to one I asked earlier of the Minister of Trade and Commerce. Will it be possible for him, at a later date, to give to the house in dollars and cents the amount of trade diverted from the United States to the United Kingdom?

It meant the employment of about 600 men. I do not have a report today as to how much of that work has been done.

Mr. Fisher: May I ask a supplementary question. As a result of the recent visit of the president of Northern Ontario Pipe Line Crown Corporation to the Port Arthur area, has the minister any information on the walkout on the pipe line there?
