would the department consider giving aid to municipalities to fight this disease?

Hon. Maurice Sauvé (Minister of Forestry): No cure is yet known for the Dutch elm disease. However, definite steps can be taken to reduce the destructiveness of the disease by removing diseased and dead trees and by the timely application of insecticides such as D.D.T. to prevent the feeding and breeding of the bark beetles that spread the causal fungus.

In these control procedures, the Department of Forestry provides technical assistance including diagnostic services to municipalities and others undertaking control, and maintains continuing surveys to define the limits and seriousness of the disease. DOMINION-PROVINCIAL ROADS TO RESOURCES
