for the Prime Minister. He indicated on April 1 that he would consider the matter and give have time to accommodate the hon. member, an answer as quickly as possible. I asked him then whether the government endorsed the compulsory retirement at age 60 of Devco employees.

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, I believe I said at that time that this question should be referred to the appropriate minister.

Mr. MacInnis: I rise on a point of order, Mr. Speaker. The question was put to the Prime Minister and as he has indicated he referred it to the appropriate minister. That minister was not here on the previous day, March 31, when he was supposed to be in the house. He was supposed to be here the following day when I asked this question. This plan is supposed to be put into effect on April 25, so the element of time is involved. Surely the Prime Minister as the head of the government must be aware of the attitude and the policy of the government in respect of the early retirement at age 60 of Crown corporation employees. As leader of the government surely he can give an answer without the assistance of the absent minister.

## HEALTH AND WELFARE

MEDICARE—PROVINCIAL USE OF FEDERAL FUNDS

Mr. Harold Winch (Vancouver East): Mr. Speaker, I intended to address my question to the Minister of National Health and Welfare who, according to the attendance roster, is supposed to be here today. In his absence perhaps I might address it to whoever is acting on his behalf. Is an investigation under way by the department in respect of the use by provinces of federal funds for medicare for general purposes? If so, is it contemplated by the minister or the government that legislation will be introduced to guarantee that federal assistance for medicare will be passed on to the general public through reduced provincial premiums?

Right Hon. P. E. Trudeau (Prime Minister): The acting minister is the Minister without Portfolio from Saskatchewan, Mr. Speaker.

## NORTHERN AFFAIRS

WHITEHORSE-MINISTERIAL STATEMENT ON SELF-GOVERNMENT

Mr. Robert Simpson (Churchill): Mr. Speaker, I should like to ask the Prime Minister whether the Minister of Indian Affairs and Northern Development was stating government policy when he said recently in Whitehorse that there was no case at the present time for establishing a greater degree of selfgovernment in the north?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, if "at the present time" is interpreted in the strict sense he was stating government policy.

Mr. Simpson: Was the Minister of Indian Affairs and Northern Development stating government policy when he also stated in Whitehorse that the conflict between public and private power should be resolved in Canada in favour of public ownership? On a point of order, Mr. Speaker, it has occurred to me that the Prime Minister did not hear the question correctly, as he appeared to want to answer.

Mr. Speaker: That was not my impression.
