PACIFIC PRESS, VANCOUVER-ENTRY INTO CANADA OF U.S. PROFESSIONAL STRIKEBREAKER

Mrs. Grace MacInnis (Vancouver-Kingsway): In the absence of the Minister of Manpower and Immigration I should like to direct a question to the Acting Prime Minister arising out of the strike at Pacific Press in Vancouver. Is the government aware that Leroy Norton, a professional strikebreaker from the United States, has arrived in Vancouver to help break the strike at Pacific Press?

Mr. Speaker: I wonder whether the question as asked is in order. The hon, member is asking whether the government is aware that a certain individual has arrived in Canada. I doubt whether the question, simply stated in those terms, is in order.

Mrs. MacInnis: Would the government look into these circumstances having regard to the fact that this individual came to Canada for a similar purpose on another occasion?

Hon. Mitchell Sharp (Acting Prime Minister): It is my understanding that this strike falls within provincial jurisdiction. My attention has not so far been drawn to the report.

RECONSIDERATION OF ORDER LEVYING CHARGES FOR USE OF FILMS
