Hon. Robert L. Stanfield (Leader of the Opposition): Mr. Speaker, I had a question or two for the Prime Minister, but I really could not expect them to be within the knowledge

of an Acting Prime Minister, so I would ask the Minister of Regional Economic Expansion—

Mr. Stanfield: Mr. Speaker, I am at a complete loss to understand how anybody could take any offence at that. It is a simple statement of fact—

Some hon. Members: Oh, oh!

Mr. Stanfield: To make it clear, Mr. Speaker, I did not intend to cast any aspersion on the Secretary of State for External Affairs. I simply meant to state the information would be peculiarly within the knowledge of the Prime Minister.

I would like to ask the Minister of Regional Economic Expansion whether his department proposes to take any steps to assure the continuance of the operations of the plant owned by E.M.I. Cossor in the Halifax region? I ask this question not only because of its regional significance but because in the closure of this plant, along with the closure of Fairey Aviation, the Department of National Defence would seem to have a very acute interest.

Hon. Jean Marchand (Minister of Regional Economic Expansion): Mr. Speaker, I think that the Acting Prime Minister would be the most competent one to answer, but if the Leader of the Opposition would be satisfied with a less informative answer I can inform the House that a few departments here in Ottawa are negotiating right now with the government of Nova Scotia, and we hope we can keep this plant in use.

Mr. J. M. Forrestall (Dartmouth-Halifax East): Mr. Speaker, I wish to ask a supplementary question. Let us find out whether the Acting Prime Minister can answer as intelligently. Can the Acting Prime Minister indicate—

An hon. Member: Have you got an intelligent question?

Mr. Forrestall: I do have a fairly intelligent question, Mr. Speaker. I think it is fairly intelligent. I want to ask the Acting Prime Minister whether or not the government is taking any steps to protect Canada's financial investment on research, development, modification and sophistication of the variable depth sonar? Has the government taken any steps to protect that expertise for Canadian use?
