WHEAT—PROPOSED ACREAGE PAYMENT—AVAILABILITY  
TO PRODUCERS WHO FAILED TO OBTAIN PERMIT  
BOOKS

**Mr. H. A. Moore (Wetaskiwin):** Mr. Speaker, I wish to direct a question to the minister in charge of the Wheat Board. It is in regard to the proposed acreage payment of \$1.40 per cultivated acre as shown on last year's permit books of the producers. Will the minister ensure that there is no discrimination against those grain producers who, for different reasons, failed to take out permit books last year?

**Hon. Otto E. Lang (Minister of Manpower and Immigration):** Mr. Speaker, the bill which will soon be before the House indicates eligibility for payments for permit-holders who had their permits by March 1.

**Mr. Moore:** Would the minister not agree that a different basis could be used, because is it not true that there is no law which says that a producer must take out a permit book?

**Mr. Speaker:** Order. It seems to me that the hon. member's supplementary is in the form of an argument and a submission.

## GRAIN

WHEAT—PROPOSED ACREAGE PAYMENT—AVAILABILITY  
TO PRODUCERS WHO FAILED TO OBTAIN PERMIT  
BOOKS—APPEAL PROVISION

**Mr. Cliff Downey (Battle River):** My question is supplementary to the one the hon. member for Wetaskiwin asked of the minister in charge of the Wheat Board. It concerns the possibility of an appeals provision being established in regard to the matter of qualification for the stabilization fund payments of producers who, in the past, have not had occasion to have permit books and who have been growing grain but in effect have been feeding it to livestock. Will an appeals procedure be set up for them?

**Hon. Otto E. Lang (Minister of Manpower and Immigration):** None is anticipated. I think it should be understood that the transitional payment is related to the stabilization fund which itself will be related to the marketing opportunities for grain, and therefore it is intended for those producers who are in the grain selling business.

**Mr. Crouse:** I wish to raise a point of order, Mr. Speaker, based on the reply given to my question by the Minister of Fisheries and Forestry. I have evidence before me which indicates that no funds have been made available for this type of training, and I would ask the minister to clarify this situation so that students—
