### CROCUS FOODS—SUGGESTION FEASIBILITY STUDIES ON ESTABLISHMENT OF PROPOSED PLANT BE MADE AVAILABLE TO MILK PRODUCERS

**Mr. Jake Epp (Provencher):** Mr. Speaker, may I direct a question to the Minister of Regional Economic Expansion relating to Crocus Foods. As a number of public meetings have been held in Manitoba in recent weeks about this plant, and as there is deep division about the proposed building of this plant and provincial government involvement in milk processing, will the minister indicate to the House if feasibility studies are available, so that decisions might be based on fact rather than on the basis of discussions which have taken place without the benefit of feasibility studies?

Hon. Donald C. Jamieson (Minister of Regional Economic Expansion): Mr. Speaker, I am not sure that I accept the final few words of the hon. gentleman's suggesion that there is a lack of feasibility studies. Since the matter was first brought to my attention, I made a number of inquiries and was in touch with some of his colleagues with regard to the inquiries. Just today I received the most recent submissions from the company, setting forth certain fundamental changes in the structure of the proposed corporation. I am examining these now and will obviously need to decide soon, because the whole construction phase depends on something being done. I should add

that strong representations have been made on both sides of the issue, which makes this an exceedingly difficult question. I shall be glad to discuss it with the hon. member, if he so desires.

Mr. Epp: A supplementary question, Mr. Speaker. I did not suggest that there are no feasibility studies. I suggested they are not available to producers. Will the minister make certain aspects of the feasibility studies available to the two producer groups who do not agree with the project, in order that they may know how the proposals will affect the future of their industry?

**Mr. Jamieson:** Mr. Speaker, the hon. member must understand that it does not fall within my authority or responsibility to make such documentation available within the province. Our role essentially is to decide for or against an incentive grant. The government of Manitoba is carrying on negotiations with various producer groups. My information today is that the Manitoba Milk Producers Marketing Board has been involved and made satisfactory arrangements with Crocus Foods. The only question remaining in my mind is whether that arrangement, and what flows from it, will be sufficient to allay the fears of those who feel it will harm other aspects of the dairy industry.
