CANADA ASSISTANCE PLAN

MEASURE TO AMEND

The House resumed from Monday, December 9, consideration of Bill C-32, an act to amend the Canada Assistance Plan, as reported (without amendment) from

the Standing Committee on Finance; and the motion of Mr. Langdon (p. 5964).

Mr. Guy H. Arseneault (Restigouche—Chaleur): Mr. Speaker, I do not intend to speak too long. I just want to review a few comments with regard to this bill.

I can say without any hesitation that I am definitely opposed to Bill C-32, a measure that demonstrates this government's failure to defend the poor in this country.

Faced with a situation in which more and more Canadians will have to resort to welfare, the Tory government is putting a cap on our Canada Assistance Plan. This measure will put a 5 per cent cap on funding for welfare plans in Ontario, British Columbia and Alberta. Unfortunately the need for funding will probably be greater in these provinces as a result of the negative impact of Tory policies such as the GST and free trade on our economy.

As you know, Mr. Speaker, the Canada Assistance Plan is a major component of the kind of program vision that requires close co-operation between the federal government and provincial governments. The Canada Assistance Plan is a shared cost program. We also have Established Programs Financing, which focuses mainly on post-secondary education and health care which is in bad shape and the comprehensive financing formula, under which the federal government works together with the provinces in the areas of health care and education.

The purpose of all these programs is to ensure that Canadians, especially those in greatest need, receive government assistance. However, the Tory government's policies have clearly shown us that the government has chosen to ignore Canadians and the fact that many are living in poverty.

The number of homeless people, people who live on the street and who are barely surviving, is increasing. There are young people on our streets who are getting into drugs and prostitution and who will never be able to get out of that world. Obviously this would not be happening if the community could offer them alternatives, some kind of programs and social assistance to tide them over difficult periods.

The government is acting irresponsibly by capping the Canada Assistance Plan.

According to the federal government's figures, the three provinces affected will lose \$2.135 billion in federal
