A documentary piece of evidence relating to the Russell-Blair plot has appeared in the form of a letter written by David Russell to C. A. Danesneau, editor of La Presse. This letter, which is reprinted in another column, shows that the transfer of La Presse from Mr. Berthiaume to Mr. Russell took place on Wednesday, Oct. 12, just fifteen days before nominations for the general elections. Its contents point strongly to the conclusion that a political plot was in process of development three weeks previous to the election. The letter is signed by Mr. Russell, and is addressed to Mr. Danesneau with the plea that it is only partly revealed in the letter. These gentlemen will have to make explanations to their friends in Quebec, and they are likely to have considerable difficulty in doing so.

As for David Russell, it is evident from his letter to Mr. Danesneau that he contemplated a political coup and was ready to betray the cause of imperialism while still the friend and confidant of the man who upheld imperialism. It shows also that the plot was directly related to the Grand Trunk Pacific Railway contract and to Hon. A. G. Blair's resignation of the chairmanship of the railway commission. Mr. Russell clearly intended to use the Grand Trunk Pacific Railway, working in alliance with newspapers and politicians who opposed it.

The next important thing to be shown is whether or not Hugh Graham of the Grand Trunk was a partner in, and if not a partner, a party to everything that David Russell did in connection with the purchase of La Presse. It is now up to Mr. Graham to deny the Globe's charge that the editorials presented to La Presse for publication after the transfer originated in The Star office and that he was cognizant of the efforts to switch the policy in Mr. Russell's letter to Mr. Danesneau bear all the marks of the brain of a gift enterprise expert.
