for the salary of James Mitchell, late Inspector of Lighthouses in New Brunswick, from the 1st October, 1891, to the 31st December, 1891, being the date between his suspension and the date of his superannuation, three months, at \$100 a month, \$300, for the year ending 30th June, 1897.

29. Resolved, That a sum not exceeding Ten thousand dollars be granted to Her Majesty, to provide tug for Winter Mail Service between Cape Traverse, Prince Edward Island, and Cape Tormentine, New Brunswick, for the year ending 30th June, 1897.

30. Resolved, That a sum not exceeding Three thousand dollars be granted to Her Majesty, for Mail Subsidies and Steamship Subventions—Additional to the item of \$5,000 provided in the main estimates—The whole amount (\$8,000) to be applied as follow:—The service to be performed by two approved steamers thus, daily service between Port Mulgrave, Arichat and Cape Canso; four trips a week between Port Mulgrave and Guysborough; two trips a week during the season of navigation between Port Mulgrave and Port Hood, and one of such trips to be extended to Margaree, for the year ending 30th June, 1897.

31. Resolved, That a sum not exceeding Fifteen thousand dollars be granted to Her Majesty, for steam service between St. John and Halifax and London (pending negotiations respecting the Fast Line) in addition to the \$25,000 provided in the main estimates; the whole sum of \$40,000 to be applied as follow:—In the summer months a service between St. John, Halifax and London, as hitherto; in the winter months direct services from St. John to London, and from Halifax to London, for the year

ending 30th June, 1897.

32. Resolved, That a sum not exceeding Seven thousand five hundred dollars be granted to Her Majesty, for steam service (pending negotiations respecting the Fast Line) between St. John, New Brunswick, and Glasgow, during the ensuing winter, for

the year ending 30th June, 1897.

33. Resolved, That a sum not exceeding Seven thousand five hundred dollars be granted to Her Majesty, for steam service (pending negotiations respecting Fast Line) between St. John, Dublin and Belfast, during the ensuing winter, for the year ending 30th June, 1897.

34. Resolved, That a sum not exceeding Two hundred and twenty-five dollars be granted to Her Majesty, amount required to refund to Mr. James J. Foster, of Birtle, Manitoba, the bonus paid by him for a timber berth in what was known as the "Dis-

puted Territory," for the year ending 30th June, 1897.

35. Resolved, That a sum not exceeding Five hundred dollars be granted to Her Majesty,—Amount required to recoup the North-west Mounted Police for assistance to destitute Half-breeds, during the years 1895-96 and 1896-97, for the year ending 30th June, 1897.

36. Resolved, That a sum not exceeding One thousand dollars be granted to Her Majesty, to provide for the purchase of 500 copies of the Canadian Parliamentary

Companion, for the year ending 30th June, 1897.

- 37. Resolved, That a sum not exceeding Thirty-five thousand dollars be granted to Her Majesty, to provide for another expedition by water to Hudson's Bay to settle, if possible, the practicability of the route for commercial purposes, for the year ending 30th June, 1897.
- 38. Resolved, That a sum not exceeding Five hundred dollars be granted to Her Majesty, in aid of completion of monument to soldiers of North-west rebellion, City of Toronto and private citizens each to provide similar amounts, for the year ending 30th June, 1897.

39. Resolved, That a sum not exceeding Five thousand dollars be granted to Her Majesty, towards the expenses of the meeting of the British Medical Association in

Montreal, for the year ending 30th June, 1897.

40. Resolved, That a sum not exceeding Three thousand dollars be granted to Her Majesty, for payment of transportation expenses of His Excellency Li Hung Chang and suite through Canada, from Niagara Falls to Vancouver, for the year ending 30th June, 1897.
