## INQUIRIES FOR RETURNS

PUBLIC SERVICE-TRAVELLING AND LIVING EXPENSES

On the orders of the day:

Mr. J. G. Diefenbaker (Lake Centre): I again want to bring to the attention of the Secretary of State the fact that the return which was ordered over six weeks ago with regard to travelling expenses has not been brought down. Yesterday or the day before he said there were a couple of departments that were still held back. Surely that should be available; and I would ask the minister-

Mr. Speaker: Order.

Mr. Diefenbaker: I am raising a question of privilege, sir. These returns are too long overdue. Will the Secretary of State bring down the returns for all but the two departments that are holding back these returns? Will he bring the others down?

Hon. F. G. Bradley (Secretary of State): I do not think that on any occasion I said that these returns were being held back.

Mr. Diefenbaker: No?

Mr. Bradley: I said that they were not ready.

Mr. Diefenbaker: All right.

Mr. Bradley: I will make inquiries and do what I can to facilitate the matter.

OFFENCES UNDER FEDERAL STATUTES-PROSECU-TIONS AND CONVICTIONS IN NEWFOUNDLAND

## OLD AGE PENSIONS

STATUS OF PERSONS COMPENSATED FOR FLOOD DAMAGE

Mr. Stanley Knowles (Winnipeg North Centre): Can the Minister of National Health and Welfare now give me an answer to the question I asked him yesterday?

Hon. Paul Martin (Minister of National Health and Welfare): The hon. member yesterday asked me whether or not payments made to old age pensioners by way of compensation for destruction of home as a result of the Manitoba flood would be treated as income under the Old Age Pensions Act. As he knows, of course, the decision with regard to the calculation of income, as well as with regard to the amount of the pension in any individual case, is a matter which under the act rests with the provinces. The compensation paid to an old age pensioner for loss of home by fire is not treated as income. So far as the federal government is concerned, we would treat compensation to an old age pensioner for reconstruction of his home as a result of flood damage as an analogous situation.
