UNEMPLOYMENT INSURANCE ACT

AMENDMENTS TO INCREASE RATES OF REMU-NERATION AND CONTRIBUTIONS, ETC.

Mr. McMillan: Mr. Chairman, I listened with great care to the evidence given in the committee on industrial relations by the governor of the Bank of Canada, by the deputy minister of finance and by others.
