Mr. Badanai: Speaking on a point of order, sir, I beg to submit that I merely wished to ask the minister whether he is aware of this fact and whether a protest has been made on behalf of Canada against the atrocities.

Mr. Speaker: If the hon. gentleman will refer to the precedents, I think he will find that while external affairs may be proper subjects for inquiry by oral questions before the orders of the day, the details of what goes on in various foreign countries could not very readily be handled in this way.
