MARITIME PROVINCES-REQUEST FOR EXTENSION OF SEASON FOLLOWING LATE OPENING

On the orders of the day:

David MacDonald (Prince): Speaker, my question is directed to the Minister of Fisheries and relates to the very unusual and serious ice situation in district 7B. I am wondering whether the minister or his department will give consideration to the introduction of a special fall fishing season this year because of the late date on which fishermen will be able to begin in this area this year. This is a question of some urgency, because the fishermen are now wondering whether there will be any season this year during which they can fish.

Hon. H.-J. Robichaud (Minister of Fisheries): Mr. Speaker, no decision can be made until after the spring season is completed. I realize that the date of the opening, which has now been fixed for May 16, is very late. However, toward the end of the lobster season in the last week of June we will be in a position to reassess the situation and decide what action it would be desirable to take in this regard.

Mr. MacDonald (Prince): I have a supplementary question. Can the minister give us some assurance that it will be possible to open the season next Monday as he suggested a moment ago?

Mr. Robichaud: No, Mr. Speaker, because this depends on the ice conditions.

Mr. H. Russell MacEwan (Pictou): I have a further supplementary question, Mr. Speaker. When the minister is making a decision as to whether there should be a fall fishing season in district 7B will he have his officials check all parts of that district before reaching that decision?
