Mr. J. A. Byrne (Parliamentary Secretary to Minister of Transport): 1. Construction of the terminal facilities to be added to the operations building at Fort Smith did not proceed during the 1966-67 fiscal year due to heavy program elsewhere and limited availability of funds.

2. It is the present plan, subject to availability of funds, to call tenders for construction in the spring of 1967: (a) The estimated cost of the project is \$275,000 including related works. (b) Construction has been phased in two stages, to keep the airport fully operational at all times. It is expected that it will take approximately two years to complete the project.

Question No. 1,956-Mr. Orange:

Has the C.B.C. drawn up a schedule to provide for conversion to colour television of the off-network relay transmitters and rebroadcasting stations which serve small communities across Canada?

Hon. Judy V. LaMarsh (Secretary of State): I am informed by the C.B.C. that after authority is given for this second stage of colour development, the corporation will proceed on a phased basis with priorities. In the meantime, the corporation has only tentative schedules and some preliminary financial forecasts, all of which are subject to change.

TAB CERTIFICATION FORMS, GENERAL MOTORS

Question No. 1,983-Mr. Orlikow:

Has General Motors agreed to complete the necessary forms for certification by the adjustment assistance board that the workers at General Motors Oshawa plant have been laid off as a result of the Canadian automotive program, so that those who are eligible may receive their transitional assistance benefits?

Mr. B. S. Mackasey (Parliamentary Secretary to Minister of Labour): Yes. General Motors has already supplied an initial list of those affected by the lay-off and is assembling additional information to complete the forms. General Motors has also supplied information on the nature and causes of the lay-off. The application for certification in this case was made by the United Automobile Workers.
