**Mr. Russell C. Honey (Parliamentary Secretary to Minister of Regional Economic Expansion):** (a) Provincial allotment under the Federal-Provincial Rural Development Agreement 1965-70 for 1969-70 is a maximum of \$1,378,638. No specific amount is allocated to any province until provincial requirements are known; (b) No specific amount is allocated to any province until provincial requirements are known; (c) \$4,260,000; (d) No amounts are specified on a geographical basis. Each application submitted by an industrial firm is assessed on its individual merit; (e) Nil (The trunk highway program is a statutory provision and is not part of Vote 10, but includes \$3,327,000 allocated for the Province of Newfoundland and Labrador.)

### SCHOOL SUPERINTENDENTS IN YUKON AND N.W.T.

#### Question No. 1,445—**Mr. Orlikow:**

1. Who are the Regional Superintendents of Schools in the Yukon and Northwest Territories?
2. What are the educational qualifications of each Regional Superintendent?
3. How long has each Regional Superintendent been employed by the government?
4. How many schools does each Regional Superintendent supervise?
5. How many days did each Regional Superintendent spend supervising in each school in each of the past three years?

**Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development):** 1. The Yukon Territory does not have Regional or District Superintendents of Schools. Dr. R. L. Shields is Superintendent of Education, and W. C. Rongve and J. Ferbey are Assistant Superintendents.

The Regional Superintendents of Schools in the Northwest Territories are currently J. A. Coady, H. J. Darkes, N. J. Macpherson, J. McArthur and W. W. Buell.

2. The educational qualifications of the Regional Superintendents are as follows: J. A. Coady, B.A., B.Ed., 23 years teaching experience; N. J. Macpherson, B.A., B.Ed., M.Ed., 25 years teaching experience; H. J. Darkes, B.A., B.Ed., 35 years teaching experience; J. McArthur, M.A., B.Ed., 16 years teaching experience; W. W. Buell, B.A., B.Ed., 20 years teaching experience.

The qualifications of the Yukon Territory Superintendents are: R. L. Shields, B.Ed., M.A., Ph.D., 32 years teaching experience; W. C. Rongve, B.A., B. Ed., 12 years teaching experience; J. Ferbey, B.Sc., B.Ed., M.Ed., 6 years teaching experience.

3. Mr. Coady has been employed by the Federal Government for 20 years; Mr. Macpherson, seven years; Mr. Darkes, seven years; Mr. McArthur, eight years and Mr. Buell, six years. Dr. Shields has been employed by the Government of the Yukon Territory for two years; Mr. Rongve for ten years, and Mr. Ferbey for two years.

4. Mr. Coady supervises 11 schools; Mr. Macpherson 12 schools; Mr. Darkes 13 schools; Mr. McArthur 8 schools, and Mr. Buell 12 schools.

The 21 Yukon Territory schools are not allocated to individual Superintendents.

5. The following table indicates the number of days spent supervising in Northwest Territories schools by the Regional Superintendents in each of the past three years.

Each school in the Yukon is visited by a representative of the Superintendent's office at least once a month, with the exception of the isolated Old Crow school which is visited quarterly, weather conditions permitting.
