## CANADIAN WHEAT BOARD—FINAL PAYMENTS

#### Question No. 2,203-Mr. Mazankowski:

1. Is it the policy of the Canadian Wheat Board to announce final payments of grain sales and, if so, on what date was the latest announcement made?

(a) Is it the policy of the government to announce final payments of grain sales and, if so, on what date was the latest announcement made and in the name of which cabinet minister (b) has any official or non-official complaint been brought to the attention of the government and, if so (i) in what form (ii) on what date (iii) by whom (iv) what was the response of the government and on what date was it made?

#### Mr. Robert Bockstael (Parliamentary Secretary to Minister of Transport):

- 1, 2. (a) It has been the practice for many years for both the Canadian Wheat Board and the government to concurrently issue press releases providing the results of the Board's pool account operations and the final payment levels. The most recent announcements were made on January 9, 1981, and pertained to the 1979-80 pool accounts. The announcement by the government was made in the name of the Minister of State responsible for the Canadian Wheat Board.
  - (b) On January 9, 1981, the Canadian Wheat Board advisory committee passed a motion as follows:

"That in future announcements of final payments be made by the Canadian Wheat Board and not by the Minister of State for the Canadian Wheat Board or the minister's office."

The government has noted this motion but has not responded to it.
