The information requested is not recorded in such a way that it could be extracted without the expenditure of an inordinate amount of time, work and money.

CBC—SUBJECT OF ESPIONAGE ON NEWSCAST

Ouestion No. 1.202-Mr. Cossitt:

Is it the policy of CBC to eliminate, wherever possible, from newscasts, any mention of the subject of espionage, particularly including Soviet espionage despite the fact that such subjects are covered by other news media and, if so, did Mr. Mark Starowitz, CBC producer and future TV news editor, have any input into creating it and, if so, was it before or after his associations with Mr. Konstantine Geyvandov, former Russian correspondent in the Ottawa Parliamentary Press Gallery?

No. The content of newscasts is based on the news events of the day plus feature items on specific subjects of general interest.

STATISTICS CANADA—USE OF SOCIAL INSURANCE NUMBER

Question No. 1,210—Mr. MacKay:

- 1. Does Statistics Canada, as empowered by the Statistics Act, impose penalties on individuals refusing to provide their Social Insurance Number (SIN) in response to a questionnaire or survey from the agency requiring such a number?
- 2. Does Statistics Canada, as empowered by the Statistics Act, establish cross linkages between files containing personal information on individuals without their knowledge and consent, through the use of Social Insurance Numbers to access provincial health, education and justice records and, if so, does the information collected become part of a Federal Information Bank (FIB) under the provisions of the Canadian Human Rights Act?

Hon. J.-J. Blais (Minister of Supply and Services): Statistics Canada reports: 1. No.

- 2. (a) Statistics Canada does, in a very few instances, use the SIN as a record linkage tool to assist in the access and subsequent processing of provincial records for statistical purposes. In the area of health statistics, no regular use is made of the SIN, although a number of research projects in the area of occupational hazards have been undertaken with the use of the SIN. In the area of justice statistics, the bureau receives SIN coded records from corrections institutions in five provinces. The SIN is used in this program to verify information through a follow-up process. However, this corrections statistics program will be phased out by the end of calendar 1980. In the area of education statistics. educational staff records and university student graduation records contain the SIN, where the individual chooses to disclose the number.
 - (b) None of the information contained in records described in 2(a) above becomes part of a Federal Information Bank under the provision of the Canadian Human Rights Act.
