## THE RIGHT HONOURABLE THE LEADER OF THE OPPOSITION

INTENTION TO STEP DOWN AS LEADER OF LIBERAL PARTY— TRIBUTES TO ROLE PLAYED FOR CANADA AND PARLIAMENT— MOTION UNDER S.O. 43

**Right Hon. Joe Clark (Prime Minister):** Mr. Speaker, I would like the permission of the House to move, under Standing Order 43, a motion which is seconded by the hon. member for Winnipeg North Centre (Mr. Knowles):

That this House express its gratitude and appreciation to the Right Honourable the Leader of the Opposition for his service to the House, his party and country, and expresses its hope that he will continue, as the Right Honourable Member for Mount Royal, to contribute his formidable talents to Parliament and to Canada.

[Editor's Note: Members of the House stood and applauded.]

Mr. Speaker: It is my pleasure to record that the unanimous consent of the House was given to the presentation of the motion and that it was obviously adopted unanimously.

Hon. Allan J. MacEachen (Cape Breton Highlands-Canso): Mr. Speaker, if you are putting the motion, I would like to say a word on it.

**Mr. Speaker:** The House has heard the terms of the motion. It is moved by Mr. Clark, seconded by Mr. Knowles:

That this House express its gratitude and appreciation to the Right Honourable the Leader of the Opposition for his service to this House, his party and country, and expresses its hope that he will continue, as the Right Honourable Member for Mount Royal, to contribute his formidable talents to Parliament and to Canada.

Mr. MacEachen: Because this is a debatable motion I would like to take a few minutes to speak to it. I begin by expressing my sincere appreciation to the Prime Minister (Mr. Clark) for putting the motion to the House, which was received on both sides with great enthusiasm.

For myself, I would like publicly to say what I said to the leader of my party; that is, how deeply saddened I am at the decision he has taken to step down from the leadership of the Liberal party. It has been my view since the last election that the right hon. member for Mount Royal (Mr. Trudeau) could continue to lead our party and could succeed in returning this party to office in the future.

I am happy to associate the members of my party with the tributes and good wishes to the Leader of the Opposition (Mr. Trudeau) contained in the motion.

It has been a pleasure for many of us to be associated with the right hon. member for Mount Royal through his years in Parliament. His contribution to the country cannot be gainsaid. He has been subject to criticism, but he knows best of all that the one way not to receive criticism is to do nothing at all. That has not been the story of his life.
