could jeopardize the security of these individuals and their families.

- 11. Yes. (a) October 27-29, 1980, (b) discussions are at a preliminary stage, (c) the second round of Consular discussions is likely to be held in the course of this year and it would be premature at this time to predict the outcome.
- 12. In the Second Report of the Commission of Inquiry Concerning Certain Activities of the Royal Canadian Mounted Police, the Commissioners noted that "the Security Service has been known to collect systematically, information on all persons who travelled to Communist bloc countries" (p. 471). The Government considers that the disclosure of additional details would not be in the public interest.

INTERNATIONAL MONETARY FUND CONFERENCE

Question No. 4,536—Mr. Mazankowski:

Did the Government organize the IMF Conference held in Toronto during September 1982 and, if so (a) what amount did it spend (b) how many Government employees or consultants were involved in organizing the Conference and for what period of time (c) how many persons attended the Conference on behalf of the Government and, in each case, what was his/her name and in what capacity did he/she attend?

- Hon. Paul J. Cosgrove (Minister of State (Finance)): The Government in co-operation with the secretariat of the two institutions organized the joint annual meetings of the International Monetary Fund and the International Bank for Reconstruction and Development in Toronto during September, 1982.
- (a) The total costs of the meetings to the federal Government are not yet available but are expected to be less than \$6 million
- (b) A total of 12 Government employees were involved in organizing the meetings: one person for two years, three people for 22 months, and the other eight people for six months, of which two months were on a full-time basis. An additional seven were seconded for periods of two weeks or less. In addition, nine local personnel were hired in Toronto for periods ranging from three to six weeks and one secretary was hired for six months. A total of 24 hostesses were hired for eight days during the meetings.
- (c) The official delegation was composed of the following people: the Hon. Allan J. MacEachen, Deputy Prime Minister and Minister of Finance; the Hon. Mark MacGuigan, Secretary of State for External Affairs; the Hon. Pierre Bussières, Minister of State for Finance; the Hon. Ed Lumley, Minister of State for International Trade; Mr. Douglas Fisher, Parliamentary Secretary to the Minister of Finance; from Finance: Mr. Ian A. Stewart, Deputy Minister; Mr. Bernard J. Drabble, Associate Deputy Minister: Mr. G. E. Shannon, Assistant Deputy Minister, International Trade and Finance; Mr. Michael G. Kelly, Director, International Finance Division; Mr. John C. Coleman, Director, International Programs Division; Mr. Robert Pattillo, Press Secretary to the Minister

of Finance: Mr. Michael Gillan. Assistant to the Minister of Finance: Mr. Alain Dudoit, Senior Departmental Assistant to the Minister of Finance: Ms. Laurette Gauthier, Legislative Assistant to the Minister of Finance; Mr. D. Blake MacKenzie, International Finance Division (Delegation Secretary); from Bank of Canada: Mr. Gerald K. Bouey, Governor; Mr. D. J. R. Not all of these delegates were present for the entire period of the meetings. In addition eight people from Ottawa served the delegation as assistants and secretaries. These figures do not include those participating in the Conference organization mentioned under (b) nor a number of officials who were involved in trade promotion and similar activities but did not attend the annual meetings.

HOSPITALITY AND ENTERTAINMENT AT IMF CONFERENCE

Question No. 4,538—Mr. Mazankowski:

- 1. Did the Government provide hospitality and entertainment during the IMF Conference in Toronto in September, 1982 and, if so, what was the total cost?
- 2. For each event, such as a reception, dinner or party (a) for whom was it held (b) how many persons were in attendance (c) what entertainment/hospitality was provided (d) what was the cost?
- 3. Were any events catered and, if so (a) by whom and at what cost (b) were tenders requested?

Hon. Paul J. Cosgrove (Minister of State (Finance)): 1. The Government did provide hospitality and entertainment for the delegates to the joint annual meetings of the International Monetary Fund and the International Bank for Reconstruction and Development held in Toronto. The total cost was \$288,359.

2. The events were as follows:

In addition gifts were provided to delegates and spouses at a cost of \$55,303. Floral arrangements at the various receptions cost \$1,763 and printing of programs, invitations, signs cost \$21,261.
