Disraeli's Programme.
 Mr. Disraeli seems to have determined on moderate reforms, based on careful inquiry, instead of radical measures founded on theory. The difficulty of land transfer is an abuse the existence of which it is difficult to understand. We think it is a pity that the speech conveyed, should oppose the simplifying of the process of transferring real estate from one owner to another. The traders and bankers, men who are making money and desire to buy land, will be glad that the most of transfer is to be lessened. The full text of the speech was received by mail yesterday. The portion that was not given in the associated press dispatch is as follows: You will probably be of the opinion that the reorganization of the Judiciary and the modification of the administration of Law and Equity which were effected in England by the enactment of the last session, ought to be extended to Ireland. You will be asked to devote a part of your time to the consideration of these objects. The greatest part of these changes, applicable to the tribunals in Scotland, but you will be invited to consider any satisfactory means of bringing the procedure upon Scottish appeals into harmony with the recent changes. Among other measures relating specially to Scotland, a bill amending the law relating to land rights and the mode of the transfer of land will be laid before you. A bill will be introduced dealing with such parts of the law relating to the sale of intoxicating liquors as have given rise to complaints and appear to deserve the interference of Parliament. Your attention will also be directed to the laws affecting Friendly Societies. These laws will require grave consideration, I pray the Almighty to guide your deliberations.

There can be little difficulty in carrying out this programme in the present House. The honor legislation will, doubtless, be in the landlord, interest, rendering less stringent some of the regulations that govern the trade.

The debate in the Assembly, yesterday, was not very dignified. Mr. Lindsay, feeling sore at the intimation that he had sold his support to the Government for \$100, raked up some of the scandal that has circulated about those who attacked him. Our politics would be far more respectable if we could have party jobs done up and lines drawn which men could not step without disgracing themselves.

The Courier wants to know if it is possible that any public printing has been given to newspaper proprietors who have no job offices, and farmed out by them at a profit. The printer will find, on examining the public accounts for 1871-2, that such was done to the tune of several thousand dollars, and will then be able to understand why a free-school Government in New Brunswick is supported by a journal that did not support a free-school candidate for Parliament.

Holy Cross Bridge, Moncton.
 The contract for the construction of the Holy Cross Bridge, Moncton, Mar. 19. Mr. W. M. Gough and other M. P. P. are moving for papers in reference to certain bridges and roads in the Province, perhaps a statement might be obtained of the amounts paid and the work done for the construction of the Holy Cross Bridge in this town. It is not known by the philanthropic firm of C. & C. Hart, if the Province would ever have been taxed to build a bridge nominally for the benefit of the public, but really for the purpose of bringing to the store of the said enterprising firm.  A meeting was held last evening in the Temperance Hall, King Street. O. D. Westmore, Esq., occupied the chair. The object of the meeting was to form a Prohibitory League for the City and County of St. John. Messrs. Andre Gushing, O. D. Westmore, S. B. Patterson, J. R. Woodburn and J. P. Bell were appointed a committee to form a code of laws for the organization. A resolution was passed asking the assistance of the clergymen of the city in obtaining prohibition. Several gentlemen addressed the meeting, after which it adjourned until Friday next.

Canadian, British and Foreign.

 LONDON, March 20, p. m.
 Consols 98 1/8; breadstuffs dull. A telegram from Berlin says, "The French Ambassador is about to resign in consequence of the unpleasant relations with Prince Bismarck. An adjournment of the Reichstag is probable on account of Bismarck's illness."
 The Daily News says that it has been given to understand on good authority that Disraeli will advise an early release of the expenditure of that sum by the proper Commissioners. It was strange that the Government waited a fortnight after the statements relating to Messrs. Tibbels & Sons, in Victoria, were made, before it was stated that the mercenary of Victoria had no interest in the firm. It was strange that luminous receipts were forwarded which were not on file. (The Commissioner here said they were on file.) Turning to Mr. Peck's case, he said that item of his covering Little Falls Bridge was covered up, also a shingle machine at 875, which might not be covered up in the other expenditures? Mr. Thiernell received and expended the money on that bridge, and was certainly a supervisor or a contractor, and as such he could not sit in the House without violating the law. Mr. Phillips, too, received the money for the Campbell Bridge without the authority of the law, and was in the same position almost as Mr. Thiernell. If the Peck matter in Alberta was properly sifted, it would be found that he also received money, which he at once handed to Charles A. Peck, then a candidate. The Chief Commissioner also told him (John E. Peck) that if he would secure Charles A. Peck's election he would give him \$250. The \$250 received by Mr. John E. Peck on behalf of the Government's claim, and the Attorney General knows that Mr. Chas. A. Peck never paid the money obtained by him to Commissioner Styles, as the Chief Commissioner had to pay Mr. Styles' claim after the fact. The Commissioner said he never gave any money to any one for election purposes in Alberta.

THE GERMAN ARMY.
 A committee of the Reichstag has voted the second time against fixing the ordinary strength of the German army at 400,000 men.
THE FENIAN CONVICTS.
 The report that the Fenian convicts will soon be released is generally discredited.
GEN. WOBERLEY arrived at Portmouth last evening.
ADVISED FROM SPAIN report that the Carlists have captured an outlying fort at Bilbao.

QUEEN'S HALL, St. Catharines, Ont., was burned last night—loss \$50,000, partly insured. There was a gas explosion during the fire, injuring several persons.
LADIES' MEETING Some disaffected collectors in Minork, Ill., got up a riot, and great excitement is reported to prevail, but so far no great damage has been done.
CUBAN REBELS SEIZED. The steamer Edgar Stuart was seized at Baltimore yesterday by order of the government.
THE TREMBLING MOUNTAIN. The latest reports from Bald Mountain are not materially different from those previously given, except that the severity of the phenomena is said to have been exaggerated somewhat.

AFTER CURTIS'S SEAT. Judge H. R. Curtis was nominated by the Democratic Legislative caucus, last evening, to succeed Charles Sumner in the United States Senate.
 (Special to the News.)
OTTAWA, March 20. Col. Shaw, of the Lake Superior Mining Ring, is here. He and McMullen intend to look the time he was Mayor in St. John, and to state in which he was left his accounts.
 Dr. Alward said that Mr. Lindsay had dragged his name in connection with matters outside the House. Mr. Lindsay's argument was that as (Alward) had done wrong, it was right for him (Lindsay) to do the same thing. He had never been charged with receiving and appropriating public moneys to himself. The change was that he had allowed certain persons to sell liquor without complying to pay license. The amount thus sold was found after four searching investigations to be \$129 during which time \$70,000 had passed through his hands, and not a cent had stuck to his fingers; and those to whom he had been lenient were poor widows and others equally deserving. Mr. Lindsay's case was different, for he had received public moneys and appropriated them to himself. He was sorry that Lindsay would allow himself to sink so low as to bring up a matter so disconnected with the House. After that investigation in his case he was re-elected Mayor of St. John and next returned to this Assembly at the head of the poll. He (Alward) had been exempted in the Assembly to swerve from his duty and resisted, but the serpent-baited Lindsay, and he did take the hundred dollars.
 The House here separated till half-past seven.

FREDERICTON, March 21.
 The House met last evening. He denied ever giving he was mortgaged to the Government. During his first year as a member business difficulties rendered it necessary for him to seek a loan, which he effected from Hatheway and Kelly. When the former died the whole claim was held by Kelly, and is to be paid off in a short time now. At the time of the Brayley House caucus Gough offered him \$1000 to vote with the Opposition, and Hamilton told him they would make him Chief Commissioner of Works, (Hamilton here denied and said Kelly had put Napier up to giving \$2). Napier said he had never taken the \$1000 and charges made against him in previous speeches, and as he had always given an unbounded support to the Government he would vote against the resolution.
 Mr. Ryan enquired Mr. Hamilton for repeating what John Peck told him, as reported. He thought John had not supported Charles Peck, and, therefore, would not be likely to get money for him from the Chief Commissioner, as stated, Albert got less great road money than any other county, so (Ryan) support was not bought. Mr. Hamilton had no right to drag John Peck's name before the County as he had done.
 Mr. Beckwith enquired Mr. Gough for using language in reference to him unfit to be reported. With the exception of a trip to Ottawa to see Auditor General
