To all to whom these Presents shall come-GREETING:

THILLES the Lands hereinafter described are Dominion Lands within the meaning of the Dominion Lands Act

AND WHEREAS William Sewis Goodman of Township Forty, Range Twenty-three West of the Second Meridian, in the Province of Sarkatchewan, in our Dominion of Ganada, Farmer.

hereinafter called the grantee has applied for a grant of the said lands and after due investigation has been found entitled to such grant in the terms herein embodied.

How Know He, that by these presents We do grant unto the grantee all the Parcel or Tract of Land, situate, lying and being in the Journship, in the Jwenty-

third Range West of the Second Meridian, in the Province of Saskatchewan.

in Our Dominion of Canada, and being composed of

the South East quarter of Section Four of the said Township, as obeson upon a map or plan of survey of the said Township, approved and confirmed at Ottawa, on the 36th day of January. A. D. 1907, by Edouard Deville, Surveyor General of Sominion Lands and of record in the Department of the Interior,

containing by admeasurement One hundred and fifty-size

Saving and reserving, nevertheless, unto Us, Our Successors and Assigns, the free uses, passage and enjoyment of, in, over and upon all navigable waters that now are or may be hereafter found on or under, or flowing through or upon any part of the said Parcel, or Tract, of Land; also reserving all mines and minerals, whether solid, liquid or gaseous, which may be found to exist within, upon or under such lands, together with full power to work the same and for this purpose to enter upon use and occupy the said lands or so much thereof and to such extent as may be necessary for the effectual working and extracting of the said minerals; and also reserving thereout and therefrom all rights of fishery and fishing hereby reserved, so far as may be reasonably necessary to the exercise of such rights.

To have and to hold the same unto the grantee in fee simple

Provided, and, in pursuance of the Irrigation Act it is hereby declared, that these presents shall not vest in the grantee any exclusive or other property or interest in or any exclusive right or privilege with respect to any lake, river, stream or other body of water, or in, or with respect to the water contained or flowing therein, or the land forming the bed or shore thereof.
