**George the Fifth**, by the Grace of God, of the United Kingdom of Great Britain and Ireland and of the British Dominions beyond the Seas **KING**, Defender of the Faith, Emperor of India.

To all to whom these Presents shall come—**GREETING** :

**Whereas** the Lands hereinafter described are Dominion Lands within the meaning of the *Dominion Lands Act*.

**AND WHEREAS**

*Gustaf Johan Olgot, of Township Fifty-five, Range Seven, West of the Fourth Meridian, in the Province of Alberta, in Our Dominion of Canada, Farmer,*

hereinafter called the grantee, has applied for a grant of the said lands and after due investigation has been found entitled to such grant in the terms herein embodied.

**Now Know Ye**,

that by these presents We do grant unto the grantee, all that Parcel or Tract of Land, situate, lying and being in the

*Fifty-fifth Township, in the Seventh Range, West of the Fourth Meridian, in the Province of Alberta,*  
in Our Dominion of Canada, and being composed of

*all that portion of the South-East quarter of Section 5M of the said Township, which may be more particularly described as follows: Commencing at the South-East corner of the said quarter section, thence Northwesterly along the East boundary of the said quarter section to the North boundary of the said quarter section; thence Westerly along the said North boundary to its intersection with the South shore of Lake No. 1; thence South-Westerly and North-Westerly along the shore of the said Lake to its intersection with the said North boundary; thence Westerly along the said North boundary to the West boundary of the said quarter section; thence Southwesterly along the said West boundary to the South boundary of the said quarter section; thence Easterly along the said South boundary to the place of commencement, as shown upon a map or plan of survey of the said Township, approved and confirmed at Ottawa, on the 18th day of April, A.D. 1906, by Edward Deville, Surveyor General of Dominion Lands and of record in the Department of the Interior,*

containing by admeasurement

*One hundred and fifty-nine and twenty hundredths,*

acres, more or less;

SAVING AND RESERVING, NEVERTHELESS, unto Us, Our Successors and Assigns, the free uses, passage and enjoyment of, in, over and upon all navigable waters that now are or may be hereafter found on or under, or flowing through or upon any part of the said Parcel or Tract of Land; also reserving all mines and minerals, whether solid, liquid or gaseous, which may be found to exist within, upon or under such lands, together with full power to work the same and for this purpose to enter upon use and occupy the said lands or so much thereof and to such extent as may be necessary for the effectual working and extracting of the said minerals; and also reserving thereout and therefrom all rights of fishery and fishing and occupation in connection therewith upon, around and adjacent to the said lands, and also the privilege of landing from and mooring boats and vessels upon any part of the said lands and using the said lands in connection with the rights of fishery and fishing hereby reserved, so far as may be reasonably necessary to the exercise of such rights.

**To have and to hold** the same unto the grantee—in fee simple.

**Provided**, and, in pursuance of the *Irrigation Act* it is hereby declared, that these presents shall not vest in the grantee—any exclusive or other property or interest in or any exclusive right or privilege with respect to any lake, river, stream or other body of water, or in, or with respect to the water contained or flowing therein, or the land forming the bed or shore thereof.
