Edward the Seventh, by the Grace of God, of the United Kingdom of Great Britain and Ireland and of the British Dominions beyond the Seas **KING**, Defender of the Faith, Emperor of India.

To all to whom these Presents shall come—**GREETING:**

Whereas the Lands hereinafter described are Dominion Lands within the meaning of the Dominion Lands Act.

AND **WHEREAS**

Otto Ferdinand Malmberg, of Township Nineteenth Range, Twenty-five West of the Fourth Meridian, in the Province of Alberta, in Our Dominion of Canada, Farmer,

hereinafter called the grantee, has applied for a grant of the said lands and after due investigation has been found entitled to such grant in the terms herein embodied.

Now Know Ye, that by these presents We do grant unto the grantee, all that Parcel or Tract of Land, situate, lying and being in the *Nineteenth Township, in the*

Twenty-fifth Range, West of the Fourth Meridian, in the Province of Alberta, in Our Dominion of Canada, and being composed of

The South East quarter of Section Twenty-eight of the said Township.

containing by admeasurement *One hundred and sixty (160)* acre, more or less;

SAVING AND RESERVING, NEVERTHELESS, unto Us, Our Successors and Assigns, the free uses, passage and enjoyment of, in, over and upon all navigable waters that now are or may be hereafter found on, or under, or flowing through or upon any part of the said Parcel or Tract of Land; also reserving all mines and minerals which may be found to exist within, upon, or under such lands, together with full power to work the same, and for this purpose to enter upon, and use and occupy the said lands or so much thereof and to such an extent as may be necessary for the effectual working of the said minerals, or the mines, pits, seams and veins containing the same; and also reserving thereout and therefrom all rights of fishery and fishing and occupation in connection therewith upon, around and adjacent to the said lands, and also the privilege of landing from and mooring boats and vessels upon any part of the said lands and using the said lands in connection with the rights of fishery and fishing hereby reserved, so far as may be reasonably necessary to the exercise of such rights.

To have and to hold the same unto the grantee in fee simple.

Provided, and, in pursuance of the *Irrigation Act* it is hereby declared, that these presents shall not vest in the grantee any exclusive or other property or interest in or any exclusive right or privilege with respect to any lake, river, stream or other body of water, or in, or with respect to the water contained or flowing therein, or the land forming the bed or shore thereof.
