How Thow De, that by these presents We do grant unto the grantee all that Parcel or Tract of Land, situate, lying and being in the Lifty first Township in the

Eleventh Range West of the Yourth Meridian, in the Province of Alberta,

The South-East quarter of Section Twenty two of the said Township as shown upon a map or plan of survey of the said Township approved and confirmed at Ottawa on the 13th day of June A. B. 1905. by Edouard Deville, Surveyor General of Dominion Lands and of record in the Department of the Interior.

saving and reserving, nevertheless, unto Us, Our Successors and Assigns, the free uses, passage and enjoyment of, in, over and upon all navigable waters that now are or may be hereafter found on, or under, or flowing through or upon any Parcel or Tract of Land; also reserving all mines and minerals which may be found to exist within, upon, or under such lands, together with full power to work the same, and for this purpose to enter upon, and use and occupy the said lands or so much thereof extent as may be necessary for the effectual working of the said minerals, or the mines, pits, seams and veins containing the same; and also reserving thereout and therefrom all rights of fishery and fishing and occupation in connection therewith upon, around and said lands, and also the privilege of landing from and mooring boats and vessels upon any part of the said lands and using the said lands in connection with the rights of fishery and fishing hereby reserved, so far as may be reasonably necessary to the exercise of such

To have and to hold the same unto the grantee in fee simple.

Provided, and, in pursuance of the Irrigation Act it is hereby declared, that these presents shall not vest in the grantee any exclusive or other property or interest in or any exclusive right or privilege with respect to any lake, river, stream or other body of water, or in, or with respect to the water contained or flowing therein, or the land forming the bed or shore thereof.
