Edward the Seventh, by the Grace of God, of the United Kingdom of Great Britain and Ireland and of the British Dominions beyond the Seas KING, Defender of the Faith, Emperor of India.

To all to whom these Presents shall come—GREETING:

Whereas the Lands hereinafter described are Dominion Lands within the meaning of the Dominion Lands Act.

AND WHEREAS

William Henry Craig, of Township Forty-five, Range Eighteen, West of the Fourth Meridian, in the Province of Alberta, in Our Dominion of Canada, Farmer,

hereinafter called the grantee—has applied for a grant of the said lands to him in his capacity of personal representative— of the late Leslie James Craig,

in his lifetime of the same place Sixteenth day of January in the year of Our Lord, one thousand nine hundred and eight

and after due investigation has been found entitled to such grant in the terms herein embodied.

Now Know Ye, that by these presents We do grant unto the grantee—all that Parcel or Tract of Land, situate, lying and being in the Forty-fifth Township, in the Eighteenth Range, West of the Fourth Meridian, in the Province of Alberta— in Our Dominion of Canada, and being composed of

The North-West quarter of Section Thirty-two of the said Township.

containing by admeasurement One hundred and sixty (600) acre, more or less;

SAVING AND RESERVING, NEVERTHELESS, unto Us, Our Successors and Assigns, the free uses, passage and enjoyment of, in, over and upon all navigable waters that now are or may be hereafter found on, or under, or flowing through or upon any part of the said Parcel or Tract of Land; also reserving thereout and therefrom all rights of fishery and fishing and occupation in connection therewith upon, around and adjacent to the said lands, and also the privilege of landing from and mooring boats and vessels upon any part of the said lands and using the said lands in connection with the rights of fishery and fishing hereby reserved, so far as may be reasonably necessary to the exercise of such rights. And also reserving all mines and minerals which may be found to exist within or upon or under such lands, together with full power to work the same, and for this purpose to enter upon and use and occupy the said lands or so much thereof and to such an extent as may be necessary for the effectual working of the said minerals, or the mines, pits, seams and veins containing the same.

To have and to hold the same unto the grantee, in fee simple in his capacity of personal representative— as aforesaid.

Provided, and, in pursuance of the Statute in that behalf made, that these presents shall not vest in the grantee any exclusive or other property or interest in or any exclusive right or privilege with respect to any lake, river, stream or other body of water, or in or with respect to the water contained or flowing therein or the land forming the bed or shore thereof.

Charles Jerome Jones, Esquire, a Companion of Our Imperial Service Order, Deputy of Our Right Trusty and Right Well Beloved Cousin and Councillor the Right Honourable Sir Albert Henry George, Earl Grey, Viscount Howick, Baron Grey of Howick, in the County of Northumberland, in the Peerage of the United Kingdom, and a Baronet; Knight Grand Cross of Our Most Distinguished Order of Saint Michael and Saint George, Knight Grand Cross of Our Royal Victorian Order, &c., &c., Governor General and Commander-in-Chief of Our Dominion of Canada.

At OTTAWA, this Seventh day of June in the year of Our Lord, one thousand nine hundred and nine and in the ninth year of Our Reign.

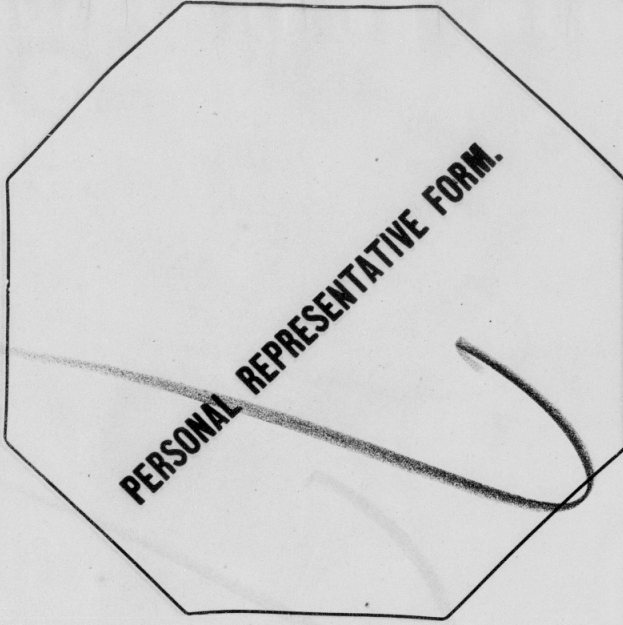
