THE WORLD'S LETTER BAG.

The Variety "Boys" and the Public Debate.

Editor World: Can anyone tell us what has become of the old-time dignity and usefulness of the public debate of the University College Literary and Scientific Society?

The time was when in "Prof's Lectures Room" our public disquisitions were characterized by decorum and decency, when essayist and reader and debator were listened to and with merited applause were awarded for both work and worth, and at the same time the not too sombre hues of propriety that characterized the literary fest: "Ab ovo usque ad malum" were relieved by flashes from the back benches, where the "men" of the various years sat. I speak of two decades and more ago.

But now it is a different thing. Our audience then were 200 or so; now they are quadrupled; the "men" are distinguished by name at least, and the "boys" have hung their banner on the outer wall. The vocabulary certainly has improved, but the moral vicissitudes have not fled like the baseless fabric of a vision.

But when the speeches commenced then the Olympic divinity where we were to see the subject, "Should the action of Government be confined to the regulation of the liquor traffic?" was ably argued so far as one could judge, but the oratory, or "boyishness," of the back benches took the matter under their entire control and the speakers on the platform merely said something when it occurred in the next breath when it occurred.

Let me not flatter myself, but I think the world that the young ladies there present played Titania to the bottom of the back benches.
