

SYNOD OF THE DIOCESE OF TORONTO.

A meeting of the Committee, appointed at the last session of the Synod, for the consideration of the best mode of making provision for the superannuation of Clergymen not on the commutation list who may be disabled by age or infirmity from attending to their duties, was held in the Board Room of the Church Society, on Wednesday, August 14th, when it was agreed that a notice should be inserted

in the Church Chronicle requesting Clergymen interested in the matter to communicate to the Rov. John Fletcher, A.M., Oskville, buch information as may enable the Committee to lay before the Synod a correct report upon the subject. The points on which they especially desire information are the age, length of service in the ministry, date of entrance into the Diocess and general state of health of the several Clergymen not on the commutation list.

The undersigned, therefore, requests non-commuted Clergymen to communicate with him on the above subject; and he would gladly receive from them and from any other Clergy nen interested in this important matter such suggestions on the most feasible mode of raising a fund for the purpose as will enable the Committee to come to a satisfactory conclusion as to the course they should recommend for the adoption of the Synod.

TRINITY COLLEGE TORONTO.

THE ANNUAL EXAMINATION FOR MATRICULATION and for SCHOLAR-SHIPS, will commence

On Tuesday, October 1st, 1867.

The following Scholarships will be open to competition :-

TENABLE FOR UNE YEAR:

TENABLE FOR THREE YEARS:

One Cameron Scholarship of £25 restricted to the sous of Clorgymen.

The holders of these Scholarships will be required to attend Lectures and Examinations in the Arts course.

All persons presenting themselves for Examination must produce testimonials of good conduct. Candidates for Matriculation must have entered on their sixteenth, and Candidates for Scholarships on their seventeenth year.

The subjects of Examination may be learned by application to the Provost of Trinity College, who will furnish any information which may be required.

One Wellington Scholarship of £50 currency per annum, one Al'an Scholarship of £45, and one Burnside and one Dickson Scholarship, each of £80, will be awarded to Students commencing their College Course in October next, according to the result of the yearly Examination in the following June.

These Scholarships are tenable for one year, but will be open again for competition to the same candidates at the end of their second year.

One Jubilce Scholarship, of the annual value of £40 currency, and tenable for two years, is open annually to the most deserving Bachelor of the year, who, having graduated in honors, shall have expressed his intention of studying for Holy Orders.

The Corporation has provided that Four Zursaries shall be open every year, tenable from year to year, for a period not execeding three years, of the value of £15 10s. per annum. Any student who shall have passed the Matriculation Examination, and shall have satisfied the Corporation that he cannot, without the aid thus afforded, avail himself of the advantages of a University education, shall be eligible for a Bursary, provided that he be not the holder of a Scholarship, *cæteris paribus*, the Sons of Clorgymen will be preferred.

QUARTERLY MEETING OF THE CHURCH SOCIETY.

The Regular Quarterly Meeting of the Church Society was held in the Board Room, on Wednesday, August 14, 1867, at 11, A.M., the Lord Bishop of Niagara in the chair. *Present*—Ven. Archdeacon Palme: Rev. Dr. O'Meara, Rev. S. B. Ardagh, Rev. J. Langtry, Rev. A. J. Broughall, Rev. E. K. Stinson, Rev. C. J. S. Bethune, Rev. H. C. Cooper, Rev. J. Fletcher, Rev. J. H. McCollum, Rev. F. L. Osler, Rev. C. E. Cartwright, Rev. Canon Beaven, Rev. Canon Brent, Rev. Canon Read, Rev. Dr. McMurray, Rev. J. Langtry, Rev. S. Givins, Rev. C. E. Thomson, Rev. The Provest of Trinity College, Rev. S. J. Boddy, Col. O'Brien, Messrs. G. Magrath, R. B. Denison, R. Spratt, C. J. Campbell, H. Mortimer, J. W. Gamble, W. Gamble, A. Gaviller, F. Farncomb, H. Mortimer.

After reading of prayers by the Rev. S. Givins, the minutes of the previousr meeting wore read and confirmed.

The Secretary then read the Financial Statement for the quarter ending 1st August, 1867; also the following Report of "The Rectory Lands Committee:"

The Rectory Lands Committee beg to report-

That their first meeting under the by-law in this behalf was held on Friday, June 28, 1867, at which all the members were present. The Secretary of the Church Society was appointed Secretary of the Committee for the ensuing year, and it was resolved that in the case of sales of Rectory Lands all moneys received be deposited in the Commercial Bank, under the name of "The Rectory Lands' Fund," and that no moneys shall be drawn from said account without the authority of the Committee, and the signatures of two of its members, countersigned by the Secretary.

It was also resolved, that all proposals for the purchase of Rectory Land's shall be made to the Rectory Land's Committee, through the Rector of the parish to which the lands belong; and it shall be his duty to report to the Committee on the same, accompanying his statement with satisfactory certificates of the value of the same.

All which is respectfully submitted.

Whereupon it was moved by Rev. Dr. O'Meara, seconded by Ven. Archdeacon Palmer, That the Report of "The Rectory Lands Committee," just read, be adopted.—*Carried*.

The Rev. H. C. Cooper presented the Report of the Committee appointed to examine into the state of the Widows and Orphans' Fund, and to report upon certain special cases referred to them for consideration. After some discussion, It was moved by Rev. H. C. Cooper, seconded by Rev. Dr. O'Meara, That the Report of the Committee on the Widows and Orphans' Fund be received.— *Carried.*

Moved by the Provost of Trinity College, seconded by Rev. Canon Beaven, That a Committee be appointed to take into consideration the by-law relating to the administration of the Widows and Orphans' Fund, with a view to reporting more equitable regulations in respect of the eligibility of applicants, and the payments to be made by the Clergy, and the amount of assistance to be given under different circumstances. The Committee to consist of the following members: The Rev. Canon Baldwin, Rev. H. C. Cooper (Convener), Rev. W. Belt, S. B. Harman, Esq., Charles Magrath, Esq., E. G. O'Brien, Esq., and the mover.—*Carried*.

Moved by Rev. H. C. Cooper, seconded by Rev. Dr. McMurray, That a Pension of \$200 per annum, in accordance with the terms and subject to the conditions of the by-law for the administration of the Widows and Orphans' Fund, be paid to Mrs. Anne Creen, widow of the Rev. Thomas Creen, deceased, such pension to commence from the 1st July last; and that the arrears claimed by Mrs. Creenviz.: \$600 for three years' pension from 1st July, 1864, to 1st July, 1867-be paid to her in three annual instalments of \$200 each, without interest, the first payment to be made on the 1st September next.—Carried.

Moved by Rev. H. C. Cooper, seconded by Rev. S. Givins, That the Secretary be instructed to pay to Mr. J. Mayerhoffer the sum of \$25 in full of pension due to the late Mrs. Mayerhoffer, for the quarter ending 30th June last.—*Carried*.

With reference to the application of Mrs. Rothwell for pension from the Widows and Orphaus' Fund—It was moved by Col. O'Brien, seconded by Rev. S. B. Ardagh, That a letter be written to Mrs. Rothwell, widow of the late Rev. J. Rothwell, stating that after a careful consideration of hor case the Society is compelled to decline the aid asked for.—*Carried*.

The Standing Committee having requested the Society to authorize the Secretary to make such arrangements with the Bank as may be necessary to enable the Mission Board to meet the call immediately to be made upon it, the funds at the disposal of the Board being inadequate for that purpose—It was moved by Col. O'Brien, seconded by Rev. Canon Brent, That the Secretary be authorized to make arrangements as above requested.—*Carried*.

The Standing Committee having recommended that a statement of the facts complained of by the Rev. Mr. Sims be transmitted by the Church Society to the Provincial Secretary, for the purpose of being laid before His Excellency the Governor General, with the respectful prayer of the Society that His Excellency will be pleased to order that an early investigation shall be held in reference to the outrage complained of by Mr. Sims, and into the general conduct of Mr. Dupont, Indian Superintendent for the District of Algoma, towards Mr. Sims, whom this Society regards as one of its most earnest missionaries; and that the Committee on Indian Missions be requested to prepare such statement :

A Memorial, prepared in accordance with said recommendation, was presented by Rev. S. Givins, and received by the Society; and Mr. Givins was authorized to add thereto particulars in regard to the complaint of the Rev. Mr. Chance.

The Petition of James Langtry and Michael Steed, on behalf of the people of Creemore, respecting the Nottawasaga Glebe, was read and laid on the table.

The Rev. Canon Beaven presented the following

Report of the Assessment Committee of the Mission Board.

In apportioning the sums to be raised by the several Districts for the Mission Fund and General Purpose Fund, the Committee have first taken the missions recommended by the District Branches, and for the grants towards which the branches are responsible, adding to the gross amount for each district one-third for the General Purpose Fund, and the proportion required from that branch towards the general work of the Diocese, calculated according to the proportion of the Episcopal Fund. The results are as follows :--

Moved by Rev. Canon Beaven, seconded by Rev. Canon Brent, That the above assessment be approved of and acted upon.—*Carried*.

An application having been made by the Incumbent and Churchwardens of Port Credit, for leave to exchange a lot recently purchased from the Crown, as a site for a Church, for another lot more suitable for that purpose :

It was moved by Col. O'Brien, seconded by Rev. Canon Beaven, That in accordance wish the application of the Incumbent and Churchwardens of Port Credit, dated August 12th, 1867, respecting the exchange of certain lands therein mentioned : Resolved, That the small piece of land lately purchased from the Government be sold, and the proceeds applied to the purchase of another lot from the Trustees of the Bank of Upper Canada, as a site for a Church.—*Carried*. Moved by Rev. S. Givins, seconded by Rev. Dr. O'Meara, That the recommendation of the Synod, at the lato meeting—viz.: that the Indian Missions of the Diocese be hereafter placed on a distinct footing—be adopted by this Society; and that, with a view to give weight to the acts of the Committee on Indian Missions, whose duty it shall be to supervise this Branch of the Society's operations, the Bishop of Ningara be the Chairman of the said Committee; and that the said Committee be hereby empowered to adopt such measures for collecting funds for the support of such Missions, as to them may appear expedient.—*Carried*.

The Book and Tract Committee having recommended that certain Books of their Miscellaneous Stock (being such as they do not think likely to be sold readily, and which yet possess a certain value, and some of them great value,) should be transferred to the Diocesan Library : and having also recommended that they be authorized to make gratuitous grants to the Hospital, the House of Industry, and the Gaol, and to any official persons interested in the welfare of particular classes of persons, such as Soldiers and Sailors, of Books or Tracts suited to the use of the particular institutions and classes of persons above alluded to :

It was moved by Rev. Canon Beaven, seconded by Rev. Dr. O'Meara, That the above recommendations be carried out.—*Carried.*

Moved by Col. O'Brien, seconded by Rev. S. B. Ardagh, That whereas certain lots in the Town of Barrie, given by the Grown as a burial ground to the Communion of the Church of England, in that town, have been illegally sold for taxes by the Municipal Council; and whereas certain other lots in the said Town, granted by the Grown for the Rectory, have under a misunderstanding been used as a burial ground; be it resolved that application be made to the Crown to accept the surrender by the Society of the lots held by it in trust for a burial ground, and to issue a new deed placing the said lots to the benefit of the Rectory : and that the Vestry of the Bs.rie Church be authorized to take such steps as may be necessary to recover possession of the lands so illegally sold,—making use of the name of the Society, but taking on themselves all expenses attending the same.— *Carried.*

Moved by Rev. S. B. Ardagh, seconded by Rev. S. Givins, That the Secretary do take the opinion of the Solicitor respecting the suit lately instituted against Dr. Lundy, to ascertain whether it be advisable to follow it up.—*Carried*.

Moved by Col. O'Brien, seconded by Rev. S. Givins, That the sale of the lot in Hamilton, being lot No. 2, Block 2, west of James Street, and the execution of the Deed by the Bishop of Toronto be, and the same are hereby, confirmed.— *Carried.*

The Secretary having submitted an estimate of certain proposed alterations in the Society's Office, and Board Room;

It was moved by Col. O'Brien, seconded by Rev. Canon Beaven, That the alterations in the Society's Office and Board Room, as proposed, be approved of.—*Carried*.

The Mission Board having—with reference to the Report of the Secretary on the subject of Mission work, and for the purpose of enabling the Rural Deans better to carry out the system therein recommended—resolved that it be recommended, that in each Rural Deanery a fund be formed by a per centage on the funds collected for the Society, for the purpose of paying the expenses of the Rural Deans, when employed on official duty : such fund to be called the Rural Deanery Mission Fund, and not to exceed £26, per annum :

Notice was given by Col. O'Brien that a By-law will be introduced at the next meeting of the Society, for the purpose of forming a fund for the payment of the Rural Deans when employed on official duty; such fund in each Rural Deanery not to exceed \$100.

The following gentlemen were proposed as Incorporated Members, to be ballotted for at the next meeting, viz.: Clarkson Jones, Esq., by Rev. A. J. Broughall; James Browne, Esq., by Rev. Canon Read.

The closing prayers were then read, and the meeting adjourned.

BOOK AND TRACT COMMITTEE.

The regular Monthly Meeting of the Book and Tract Committee was held in the Board Room on Monday, the 12th August, 1867, at 3, P.M. Present-Rov. Canon Beaven, the Provest of Trinity College, Rov. Dr. O'Meara, Rov. A. Williams, and Rov. Canon Read.

An application was received from Rov. C. E. Thomson, of Elora, for a grant of Books and Traots to the amount of \$10.—Granted.

Dr. Lett applied for a grant of Confirmation Tracts.-Granted \$2.80.

It was agreed to recommend that the Society authorize a grant to the Hospital, Gaol, House of Industry, and of single Books of Scripture in large type, Tracts specially addressed to Soldiers and Sailors and Tracts for the use of persons in Hospitals, and for prisoners.

Rov. Dr. O'Monra and Rov. Canon Read applied for grants of books for their respective Sunday Schools." Ten dollars each were granted.

TRINITY COLLEGE SCHOOL, WESTON.

Following the custom of the English Public Schools, Thursday, the 25th July, the breaking up day of the School, was observed as "Speech day." The proceedings opened at 10 o'clock with Morning Prayer and celebration of the Holy Communion in the new chapel. The clergy present where the Rev. the Provest of Trinity College; Prof. Jones, the Hend Master, Rev. Messrs. Boughall, Johnson, Bethune, Alexander, and Langtry. The sermon was preached by the Provost, from St. Matthew xx. 26, part of the Gospel for the day, the Festival of St. James the Apostle, and was an carnest and stirring appeal to the boys to set before themselves a noble and genuine ambition, both in their school studies, and in their after life. Shortly after the arrival of the 1 30 train from Toronto, the distribution of the prizes began, the ceremony taking place in the Town Hall. Notes were received from the Lord Bishops of Toronto and Ningara, regretting their inability to attend. In their absence the chair was occupied by the Provost of Trinity College. In addition to the gentlemen present at the Morning Service, the train brought many ladies and gentlemen, among whom were the Venerable Archdeacon of Toronto, the Rov. W. S. Darling, H. C. Cooper, T. T. Robarts, C. E. Cartwright, Professor Kingstone, F. W. Cumberland, S. B. Harman, H. J. Boulton, C. J. Campbell, Robert Spratt, and Clarkson Jones, Esqs. Before presenting the boys for their prizes, the head master read the reports of the examiners. Tho Provost then handed the prizes to their respective recipients-expressing in many cases the pleasure and satisfaction which the excellent answering in Divinity had afforded him, and adding a few kindly and appropriate words in each case. As time pressed it was found necessary to omit the recitations and all the songs, except two, which were admirably rendered. Addresses were then delivered by having been pronounced by the Provost the company visited the play ground, the Provost, Archdeacon Palmer, and F. W. Cumberland, Esq. ORDINATION .- On Saturday 24th August, S. Bartholomew's Day, the Bishop of Niagara admitted to the holy order of the priesthood, Messrs. Murphy and Westney, Deacons.

On the same occasion, Messrs. A. Trew, B.A., F. Bethune, B. A., J. Franck, and B. S. Hoskins were admitted to the diaconate. Mr. Trew, will undertake the duty at Markham. Mr. Bethuue's sphere of action will be the Trin. Col. Grammar School at Weston, which is establishing a good reputation as a first class educational institution. Mr. Hoskins will be stationed at Fenelon Falls, while Mr. Franck will for the present have no special charge, so that there will be at least one Clergyman in the city who may be looked to for the supply of occasional vacancies.

J Carmichael, Vice-President of the Huron, Perth and Vaterloo Associa tion, preached; but the Rev. gentlaman's eloquence is too well known to require note. CRURCH OPENING.—Christ Church, Allen Park, Co. Grey, was opened for Divine Service on Sunday, June 30. The Rev. Wm. B. Evans, incumbent, read the prayers, and Mr. W. Brookman, of London, preached in his usual eloquent and impressive maxwor to crowded congregations, both at morning and afternoon service.
