

ABSTRACT

This Directory lists useful sources of information that can be accessed through electronic means and that relate to arms control and disarmament (ACD) or to the Middle East. For the purposes of this Directory, ACD has been defined as international efforts to limit, reduce or control the implements of war. The Directory is divided into two parts: Part A includes those databases that are available through a commercial vendor, either online or CD-ROM; and Part B identifies Internet sites. Most databases/sites included in this Directory contain a significant amount of information on arms control and disarmament: some may concentrate exclusively on ACD, others may include ACD as a subset of broader issues (international affairs, defence, etc.) Other databases/sites focus on information pertaining to the Middle East. Within each Part, entries are arranged alphabetically by title, with access to subjects and to organization name provided by means of an index. In order to assist those not yet familiar with the technology involved in electronic retrieval of information, included as appendices are a glossary of terms (Appendix 1); a brief introduction to the Internet (Appendix 2); the basics of getting connected (Appendix 3); a short bibliography (Appendix 4); and the names and addresses of commercial vendors of databases referred to in Part A (Appendix 5).

دليل مصادر المعلومات الإلكترونية حول مراقبة التسلح ونزغ السلاح وحول منطقة الشرق الأوسط

ملخص

يعرض هذا الدليل بعض مصادر المعلومات المهمة التي يمكن الوصول إليها عبر الوسائل الإلكترونية والتي تتعلق بقضايا مراقبة التسلح ونزع السلاح أو قضايا منطقة الشرق الأوسط. وتمشيا مع أغراض هـذا الدليل، يُقصد بعبارة "مراقبة التسلح ونزع السلاح" الجهود الدولية الرامية إلى الحد من معدات الحسرب أو تقليصها أو مراقبتها. وينقسم الدليل إلى جزأين: يتضمن جزء (أ) قواعد البيانات التي يمكن الحصول عليها من خلال أحد الباعة التجاريين سواء على شكل اتصال مباشر أو قرص مدمج لذاكرة القراءة فقط. أما جزء (ب) فيحدد مواقع البيانات على شبكة الكمبيوت الدولية (الإنترنيت). وتحتوي معظم قواعد البيانات ومواقع البيانات المدرجة في هذا الدليل على قدر هام من المعلومات حول مراقبة التسلح ونزع السلاح، تختص بعضها في قضايا مراقبة التسلح ونزع السلاح فقط، بينما تُـدرج بعضها موضوع مراقبة التسلح ونزع السلاح كموضوع فرعبي ضمن مجموعة من المواضيع كالقضايا الدولية والدفاع، الخ. وتتمحور بعض قواعد البيانات ومواقع البيانات الأخرى حول المعلومات المتعلقة بمنطقة الشرق الأوسط. وقد تم ترتيب المداخل في كل حزء حسب الترتيب الأبجدي للعناوين ويمكن الوصول إلى المواضيع باستعمال الفهرس. ولمساعدة الأشخاص الذين ليس لديهم إلمام بتكنولوجيا الحصول على المعلومات بالوسائل الإلكترونية، تم إدراج أجزاء إضافية على شكل ملحقات مثل مسرد المصطلحات (الملحق الأول)، ومقدمة موجزة حول شبكة الكمبيوتر الدولية (الملحق الثاني)، والقواعد الأساسية لإتمام الإتصال (الملحق الثالث) ولائحة مختصرة بالمراجع (الملحق الرابع) وكذَّلك أسماء وعناوين الشركات التجارية التي تبيع قواعد البيانات والمذكورة في جزء (أ) (الملحق الخامس).

PREFACE

This Directory has been prepared as a contribution to promote practical cooperation and dialogue among the participants in the Middle East Peace Process (MEPP) on key issues of regional concern, in support of the work of the Arms Control and Regional Security Working Group (ACRS). Canada is involved in ACRS as a facilitator for the Confidence Building Measures (CBMs) in maritime affairs.

A thorough understanding of the arms control and regional security issues is a key ingredient for progress in the MEPP/ACRS, as is true in any region. In our view, such an understanding is based on timely and accurate information concerning both the background to these issues and on-going developments. The most important contribution to this understanding, of course, derives from information shared among the parties themselves as part of agreed transparency and other confidence building measures. In addition, considerable openly available information on arms control and regional security matters can be obtained by each regional participant. It is with the aim of assisting participants in the MEPP in accessing this latter type of information that this Directory has been produced.

Information on arms control and disarmament has been available electronically for a number of years through direct dial-up over telephone lines to commercial vendors. With the advent of the Internet, however, there is a burgeoning wealth of new information sources that are relevant and often free of charge; though the quality of this information may vary from source to source.

The information that is electronically available today is wide-ranging. It includes, among other things:

- newspaper articles and other current awareness material;
- bibliographic citations to research material;
- statistics and other numerical data;
- texts of key political or legal documents, such as Security Council resolutions or treaties;
- texts of other important documents, such as research reports; and
- directories or menus leading to other sources of information.

Electronic availability of this information is useful for a number of reasons. The diversity of information provides different perspectives and new facts that may not always be readily available through traditional channels. This electronic information can be accessed rapidly from almost any location in the world; virtually wherever there is adequate telephone service. Using computers also permits comprehensive and rapid searching of available information to find the data in which the user is interested. Finally, once located, the information can be easily transmitted to the user, often in a form that can be incorporated directly into reports prepared by the user himself.

To obtain these benefits -- diversity, accessibility, searchability and timeliness -- it is necessary to have the proper equipment and training. However, these are no longer exorbitantly expensive or time consuming to acquire. While this Directory can not provide a detailed guide to acquiring the necessary equipment or skills, it does include a short outline of some basic concepts and equipment requirements in order to assist the reader to gain access to the electronically available information sources described.

This Directory seeks to provide an overview of relevant electronic information sources in the fields of arms control and disarmament and of Middle East studies. It is intended to assist officials and researchers in identifying potentially useful sources for their research interests. Because of the changing nature of many of these sources, there can be no guarantee about the accuracy of the entries in this Directory. The authors have endeavoured to make it as current as possible to the end of May 1996.

It is our intention to transmit a copy of this Directory over the ACRS Communication Network, which is being maintained by the Netherlands as mentor of the Communication Working Group. We believe that the Communication Network can provide a valuable channel for the transmission of background documentation of this type as well as operational information, which ACRS participants may wish to share.

The views contained in this Directory are those of the authors and do not necessarily reflect the views of the Department of Foreign Affairs and International Trade or of the Government of Canada.

تم إعداد هذا الدليل لتعزيز التعاون العملي والتطبيقي والتشجيع على الحوار بين الأطراف المشاركة في عملية السلام في الشرق الأوسط بخصوص القضايا الأساسية التي تهم المنطقة وذلك في إطار دعم أعمال محموعة العمل الخاصة بمراقبة التسلح والأمن الإقليمي. وتعمل كندا كطرف مسهل للأمور في جلسات إجراءات بناء الثقة فيما يخص القضايا البحرية.

إن الفهم الشامل لقضايا مراقبة التسلح والأمن الإقليمي عامل أساسي لإحراز أي تقدم في عملية السلام في الشرق الأوسط وفي مجموعة العمل الخاصة بمراقبة التسلح والأمن الإقليمي، كما هو الحال في أي منطقة أخرى. ومن منظورنا الخاص، هذا الفهم يقوم على أساس معلومات صحيحة ومضبوطة من حيث الزمان فيما يتعلق بخلفيات هذه القضايا وآخر التطورات التي تشهدها. وبالطبع فإن أهم عنصر في بناء هذا الفهم هي المعلومات المتبادلة بين الأطراف المشاركة كحزء من الشفافية المتفق عليها وكجزء من إحراءات بناء الثقة الأخرى. إضافة إلى ذلك، يمكن لكل مشارك إقليمي الحصول على معلومات صريحة حول قضايا مراقبة التسلح والأمن الإقليمي. فالهدف من إعداد هذا الدليل هو مساعدة الأطراف المشاركة في عملية السلام في الشرق الأوسط للحصول على مثل هذه المعلومات.

منذ عدة سنوات، أصبح الحصول على المعلومات المتعلقة بمراقبة التسلح ونزع السلاح بالوسائل الإلكترونية أمرا ممكنا من خلال الإتصال المباشر بالباعة التجاريين عبر خطوط الهاتف. وبمجيء شبكة الكمبيوتر الدولية، برزت مصادر حديدة وغنية للمعلومات ذات الصلة بالموضوع يمكن الحصول عليها مجانا، غير أن مصداقية هذه المعلومات قد تختلف من مصدر إلى آخر.

وتشمل المعلومات التي يمكن الحصول عليها بالوسائل الإلكترونية أنواعا متعددة من النصوص والمراجع، نذكر من بينها:

- مقالات الصحف ومصادر الأنباء الأخرى.
- إحالات إلى المراجع ذات الصلة ووثائق البحث.
 - إحصائيات وبيانات رقمية.
- نصوص الوثائق السياسية والقانونية الهامة مثل قرارات مجلس الأمن أو المعاهدات.

• نصوص الوثائق الأخرى ذات أهمية مثل تقارير البحوث والدلائل أو قوائم الإحتيار التي تقود إلى مصادر أخرى للمعلومات.

إن كون هذه المعلومات متاحة عبر الوسائل الإلكترونية له فوائد عديد نظرا للأسباب التالية. إن اختلاف المعلومات وتعددها يُعطي وجهات نظر مختلفة ووقائع جديدة قد لا تكون دائما متاحة من خلال القنوات التقليدية. ويمكن الوصول إلى هذه المعلومات الإلكترونية بسرعة من أي مكان في العالم تقريبا، وبالضبط أينما وُجد الهاتف. كما أن استعمال الحاسب الآلي يسمح بإجراء بحث سريع وشامل عن المعلومات المتوفرة لإيجاد البيانات التي تهُم المستخدم. وأخيرا، وعند العثور على المعلومات المطلوبة، يمكن تحويلها بسهولة إلى المستخدم وغالبا ما تكون على شكل نصوص يمكن إدراجها مباشرة في التقارير التي يُعدها المستخدم.

وللحصول على هذه الإمتيازات -- التنوع وسهولة الوصول وسهولة البحث والظرف الزمني المناسبيجب توفير الأجهزة والتدريب المناسبين. غير أن اقتناء هذه الأجهزة والتدريب عليها لم يعد أمرا باهظ
التكاليف ولا يستغرق وقتا طويلا. فرغم أن هذا الدليل لا يعطي تعليمات مفصلة حول اقتناء هذه
الأجهزة أو المهارات، فإنه يوضح بشكل مقتضب بعض المفاهيم الأساسية وبعض المتطلبات التي يجب أن
تتوفر في الأجهزة وذلك لمساعدة القارئ على الوصول إلى مصادر المعلومات الإلكترونية المذكورة أعلاه.
يسعى هذا الدليل إلى تقديم عرض موجز عن مصادر المعلومات الإلكترونية التي لديها صلة بميدان مراقبة
التسلح ونزع السلاح والدراسات حول الشرق الأوسط. والغرض من إعداده هو مساعدة المسؤولين
والباحثين على إيجاد مصادر المعلومات التي قد تُعينهم في أبحاثهم. ونظرا لتغير شكل العديد من هذه
المصادر، فمن الصعب الجزم بدقة المداخل التي يحتوي عليها هذا الدليل. فقد حاول المؤلفون قدر المستطاع
الن يكون هذا الدليل حديثا ويحتوي على ما استجد من المعلومات إلى غاية شهر ايار/مايو ١٩٩٦.

إ ننا ننوي إرسال نسخة من هذا الدليل الى شبكة الإتصالات التابعة لمجموعة العمل الخاصة بمراقبة التسلح والأمن الإقليمي والتي ترعاها هولندا بصفتها البلد الراعي لمجموعة العمل الخاصة بالإتصالات. ونحن نعتقد أن شبكة الإتصالات يمكنها أن توفر قناة ذات أهمية لإرسال الوثائق التي لها علاقة بالموضوع بالإضافة الى المعلومات التطبيقية والعملية التي ربما يرغب المشاركون في مجموعة العمل الخاصة بمراقبة التسلح والأمن الإقليمي تبادلها.

إن الآراء التي يتضمنها هذا الدليل هي أراء المؤلفين الشخصية ولا تعكس بالضرورة أراء الوزارة الكندية للشؤون الخارجية والتجارة الدولية.

INTRODUCTION

This Directory lists useful sources of information that can be accessed through electronic means¹ and that relate to arms control and disarmament (ACD) or to the Middle East. For the purposes of this Directory, ACD is defined as international efforts to limit, reduce or control the implements of war.

The Directory is divided into two sections. Part A includes those databases that are available through a commercial vendor, or distributor, and can be accessed through two different electronic means: online; or CD-ROM. Part B is an attempt to identify the sites, mostly non-commercial, that are available on the Internet which would likely be of interest to researchers of arms control or on the Middle East.

Within both Parts A and B, entries are arranged alphabetically by title. Subject access is provided by means of an index. The record format varies somewhat between the two parts.

Part A includes:

- the title of the database;
- the name and address of the producer;
- a short description of the database vis-à-vis its coverage of ACD;
- how far back in time the information goes;
- the options for electronic access;
- the frequency with which the database is updated; and
- assigned keywords.

Part B includes:

- the title of the Internet site:
- the name and location of the information provider (individual or organization responsible for the content and/or maintenance of the service);
- its uniform resource locator, or URL;
- the designated contact, (e-mail address) if available;
- a short description of the site's scope; and
- assigned keywords.

¹To use electronic sources effectively, one should understand the underlying technology (CD-ROMs, gopher, world wide web, etc.) In order to assist those not yet familiar with this technology, several appendices have been included. See Appendix 1: Glossary of Terms, for a definition of some of the terms used in this Directory; Appendix 2: A Brief Introduction to the Internet, for an explanation of some key concepts; or Appendix 3: Getting Connected, for the basics of what is needed to gain access to both the commercial databases and the Internet.

COMMERCIAL DATABASES VERSUS THE INTERNET:

The Directory is divided into two separate parts because commercial databases are in many ways quite different from the typical sites found on the Internet. Perhaps the biggest difference between the two systems, is that most of the information obtained through commercial vendors must be purchased, whereas most of the information available through the Internet is free. Another major difference is that the producer (or compiler) of a commercial database is often not the vendor of the information. Usually the vendors of electronic databases have commercial arrangements with a multitude of database producers, and are merely the means of distributing the information, using their own value-added searching technology. The subjects covered by a large vendor such as DIALOG for example, can range from databases devoted to agriculture, through databases on business, or medicine, or zoology. The actual database producers can be either commercial operations, such as Jane's Information Group, or Information Access Company, who pull together a wide range of sources, or they can be institutions, such as the Council on Foreign Relations, who may themselves do research on the subject matter of their database. Some of the larger information companies, such as the H.W. Wilson Company, can be both a producer of databases, and also the vendor of that information. Internet sites, on the other hand, tend to reside at the provider (or producer) of the information, and are more likely to be limited to their one particular area of interest and expertise.

Since commercial vendors are in business to sell access to their databases, they will be more likely to ensure that the material is updated on a regular, clearly stated basis. They will also specify how long the information will remain on the database, for example whether it will be archived, or will be kept for the current year only, something that is not always made clear on Internet sites. The currency, type, and quality of information on the Internet varies. Older reports, documents, or legislation are often provided alongside a weekly newsletter.

Finally, it should be noted that many of the commercial vendors are now offering access to their databases through their own "home page" on the Internet, though the structure of the databases, and the necessity of having a subscription to the service remains the same as is the case for direct dial-up or other means of access.

SUBJECT COVERAGE:

Many of the databases/sites listed here, both from commercial vendors and the Internet, cover significantly wider issues than arms control or the Middle East. For those included, the information that is most relevant to the subject of ACD or Middle East studies is highlighted; the other subject areas that may also be included within the database are not necessarily listed. It should also be pointed out that for many of the databases, not every update will have arms control or Middle East information, but over time, there will be a significant amount of relevant information which warrants its inclusion in this Directory.

It should be noted that some of the databases listed here are concerned primarily with defence issues and the defence industry, rather than with arms control as such. They have been included

because, while they may be looking at the issues from a different perspective, they will often provide useful information on ACD. Those databases that focus almost exclusively on issues of concern only to the defence industry (marketing products, procurement, etc.) have not been included. A distinction should also be made between those databases that are policy oriented, and those that are technology oriented. Again, the producers of these databases have different target audiences in mind, but for doing research on arms control, both serve a useful, if different purpose. It is hoped that the databases and sites included will, taken as a whole, allow the reader to gain the widest possible perspective on the various issues involved in the subject of arms control and disarmament.

There are many databases and sites that have not been included in this Directory because their coverage of ACD per se is too infrequent, nevertheless, they do occasionally have useful information, and should certainly be noted. For example, there are many commercial databases that are scientific and technical in nature, and can sometimes be useful for obtaining very specific, technical information on various aspects of arms control, such as verification technology and equipment. One such database is the Applied Science & Technology Index, produced by the H.W. Wilson Company. Other databases, such as Wilson's Index to Legal Periodicals, concentrate on legal literature, and so might also be of interest if a legal perspective is sought. As well, there are many databases that have the social sciences as their focus, and from time to time will have information relevant to arms control and disarmament. A good example of this is the Social Sciences Index, also produced by the H.W. Wilson Company. All three of these Wilson indexes are available online, or as a CD-ROM.

Another category of commercial databases that have not generally been listed in this Directory are the news databases. These can provide useful, timely information on countries and current events, which could have relevance to ACD issues, and they can also be useful for their reporting on ACD developments. These databases can range from online services, such as *Reuters Information Services*, which provides full text access to its worldwide wire service, to databases containing the full text of a single newspaper, such as *The New York Times*. There are now far too many to name here, but most of the major commercial vendors listed in this Directory² also have a wide array of news information available. As well, many of the newspapers now have an Internet site, and at least part of their news stories are available at no cost through their site.

The coverage of ACD issues on the Internet varies. Most of the sites listed here are primarily government, university research, or independent non-profit institutions, and tend to cover broad subject areas such as international affairs, foreign policy, national and international security, peace and peacekeeping. At such sites, arms control and disarmament are discussed in broad terms or are discussed intermittently. Examples of this sort of site are The Norman Paterson School of International Affairs (see B-81), and the Stockholm International Peace Research

Institute (see B-102). However, some sites do focus exclusively on nonproliferation, arms control, and disarmament issues, such as the United Nations Institute for Disarmament Research (see B-110), and Monterey's Center for Nonproliferation Studies (see B-16).

As well, to assist those involved in the Middle East Peace Process, a number of sites focusing on Middle East studies have been included. These sites may contain political, geographical or historical information. The Middle East Network Information Center (see B-67) and the Middle East Research and Information Project (see B-68) would be good examples of this sort of site.

In selecting databases and sites for inclusion in this Directory, particular attention was given to those groups who seek to provide factual and balanced information and discussions.

AREA STUDIES:

In terms of general information about a country or region, the focus of this Directory is primarily on the Middle East. An effort has been made to include databases/sites that would be of interest to participants in the Middle East Peace Process, even if these databases/sites do not relate directly to ACD. There is, of course, a wealth of information on other areas of the world, in both commercial databases and on the Internet. For commercial databases, the *Gale Directory of Databases*³ provides subject access to both specific countries and to regions. There are as well, a number of country sites on the Internet that provide useful information in terms of a country's government, geographic, social and economic structure, and current events. In order to become familiar with a country, it is useful to visit these sites. Some examples are:

COST OF ACCESSING THE INFORMATION:

As mentioned earlier, information obtained through commercial online and CD-ROM vendors must usually be purchased. Because prices vary from vendor to vendor, and there may be several subscription options available, prices are not included in this Directory. The reader

should contact the vendor directly to get the most current subscription information.

In general, information on the Internet is free, and what is seen on the screen can be printed or downloaded. Occasionally though, a site will only provide a description of a particular report or document. Be aware that at this point, payment is usually required whenever the full report is ordered. A well-designed site will provide a price, and information on how to obtain the document. In the case of newsletters or journals, it is necessary to subscribe in order to receive the full version. For the purposes of this Directory, each site description will indicate if ordering information is provided.

LANGUAGE:

For the most part, the information contained in the databases or Internet sites listed in the Directory, is in English. Where there is also information in other languages, an effort has been made to note this in the description of the database/site.

UPDATING THIS INFORMATION/EXPLORING FURTHER:

The information contained in this Directory is current only to May 1996. The nature of the Internet in particular, is such that information within sites, and sites themselves are added or removed constantly. Even commercial databases come and go, albeit much more slowly, and postal addresses and telephone numbers for database producers and online vendors may change. As well, there are no doubt many sources of information that may have either been inadvertently overlooked, or deliberately not included, but which the reader might find useful. In order to address all these issues, a bibliography of sources⁴, either print or electronic, has been included, which will help the reader to remain current, and to explore further.

While considerable care has been taken in the selection of relevant information sources, no guarantee can be made as to the accuracy or quality of the information found within the databases or sites that have been included in this Directory, nor can any guarantee be made about the information found in this Directory.

PART A COMMERCIAL DATABASES

PART A: COMMERCIAL DATABASES

This part of the Directory covers arms control and disarmament information and Middle East information which is available from commercial vendors. It should be noted that there are very few, if any, commercial databases that deal exclusively with the subject of arms control and disarmament (ACD). Most of the information on ACD will be found within databases that cover broader subjects, such as political science, international affairs, defence, general news, etc. Information on the Middle East can be found both in separate databases, and, as with ACD information, within databases covering broader subjects.

Entries are arranged alphabetically by title of the database, with subject access provided by means of assigned keywords. Electronic access refers to the means by which the information is retrieved, either online (dialling-up directly to the database vendor's remote computer), or CD-ROM (whereby the CD-ROM is purchased and retained by the user of the information). APPENDIX 2: A BRIEF INTRODUCTION TO THE INTERNET

The Internet is a worldwide collection of computer networks that use telecommunications standards, or protocols, and telephone lines to communicate. The Internet permits users to communicate with one another electronically (e-mail), to transfer large files, and to log into a remote site to conduct database or library catalog searches. It also provides a wide variety of other information services.

The Internet is based on client-server technology. A "client" is a program which requests services from another program, often called a "server." These programs operate on different computers and communicate with each other over a network. Internet tools such as Gopher and World Wide Web are examples of client-server applications. The client-server model can be compared to how a waiter in a restaurant interacts with a chef. The waiter (client) takes the food order and sends it to the chef (server). The chef prepares the food according to the order and allows the waiter to return and serve the food.

Connecting different computers and transferring data successfully between them requires a set of rules. These rules are referred to as "protocols." These protocols are like a common language spoken between people of different backgrounds. The Internet protocols, usually referred to as Transmission Control Protocol/Internet Protocol (TCP/IP), allow computers connected through networks to communicate with one another.

There is a wide variety of Internet tools or information services available. Each performs a specific function. Internet tools or services can be categorized according to function, as follows:

- Communication
 E-mail
 Mailing Lists
- Remote Login Telnet
- File Exchange
 File Transfer Protocol (FTP)
- Searching and Information Retrieval
 Gopher
 World Wide Web (WWW)

Mailing lists, an extension of e-mail, are available on the Internet. Users send an electronic message to an e-mail address or a "mail reflector." The message is then forwarded to a list of "subscribers." A subscriber or a number of subscribers may respond by sending a message back to the entire group. Mailing lists are usually organized according to subject or professional

occupations. The advantages of mailing lists are that they promote information access, information sharing, and professional development.

An application program using the **Telnet** protocol allows users to connect to other computer systems on the Internet and use the resources located physically at that site. In effect, the user's terminal is directly linked to the remote computer. For example, Telnet provides access to online public access catalogs and a variety of databases.

FTP (File Transfer Protocol) defines how files are transferred from one computer to the other. On the Internet, a software program obtains text files or software from a remote computer using the File Transfer Protocol. By entering the FTP command, users can connect to a remote computer, obtain a directory listing, view file listings, select a file, and then send files to their station. Anonymous FTP allows users to access sites which permit free file transfer. Users do not need to have an authorized ID or account.

A Gopher is a menu-based system which helps users find resources on the Internet. Resources are located by browsing through a number of menus or lists. When users select a resource from the menu, they do not need to identify the address, or the proper name, the system automatically connects to the resource after a selection has been made. Once a text file or resource of interest has been found, the users can print or save the information.

The World Wide Web is an Internet information service based on hypertext technology. A hypertext document contains text and links to other documents. By selecting the highlighted words contained in the hypertext document, users can obtain additional information about the topic. These highlighted words are in fact links to other documents which may be text, graphics, audio or video clips. The actual document may be on a local host or at a remote location. What makes the Web so powerful and flexible is that the highlighted word, called a hypertext link, is not limited to any one type of Internet resource or service; rather, it can show an image, play an audio clip, initiate a Telnet session, and so on.

Hypertext markup language (HTML) is the language in which World Wide Web hypertext documents are written. HTML contains codes or "tags" that indicate which sections of text are headings, paragraphs, lists, and so on. There are also tags indicating hypertext links. This is the feature that allows users to click on a highlighted word or item and connect to another document.

For the purpose of this discussion, a home page is a hypertext document which serves as the first hypertext page users sees when they arrive at a specific World Wide Web site on the Internet. The page serves a function similar to a table of contents in a book or journal. Typically, it describes the organization responsible for creating and maintaining the site. Often, hypertext links will provide access to other information and services.

To access the Web a browser is used. This is a program that allows users to read a hypertext document. There are a variety of browsers available, e.g. Lynx, Netscape, Mosaic. The type of browser is determined by the user's local computer system.

A critical factor for success in using the Internet is understanding how people, machines, and resources are addressed on the Internet. Similar to postal addresses and telephone numbers, Internet addresses have rules and conventions for use.

TCP/IP defines how each computer on the Internet is distinguished from every other. Each computer has a unique Internet number. This number is referred to as an "IP Address." IP addresses are difficult for people to use so textual equivalents were created. Thus for almost every IP address there exists a textual (domain) name address. For example:

IP Address

Domain Name Address

192.41.140.35

www.nato.int

Domain names are hierarchical. Each portion of the address, separated by a period, is called a domain. Each address begins with the most specific domain at the left (the computer's name), and ends with the most top-level domain to the right. The middle portion usually indicates the department or organization involved. For example:

pa.acda.gov

pa	computer or server name
acda	U.S. Arms Control and Disarmament Agency
gov	government site

Top-level domains include geographic as well as organizational designations. For example:

us	USA
ca	Canada
org	an organization
com	a commercial site
mil	a military site
edu	an educational site

A Uniform Resource Locator (URL) is a standard used on the Internet for specifying the location of information and the Internet tool needed to access it. This standard format incorporates the domain name address. The method of access, or Internet tool, is listed first, followed by a semi-colon and a double forward slash. The domain name address is listed next, followed by the file path of the document.

APPENDIX 3: GETTING CONNECTED

COMMERCIAL DATABASES:

To connect to commercial online databases, the following are required: a computer, a modem, communications software, and the telephone number for a data communications network (e.g. Datapac, SprintNet, etc.) to connect to the online service. An online session involves a user connecting via a computer, modem, and telephone lines to a remote computer system, entering a search statement, and receiving a list of relevant database records. The database physically resides on the vendor's computer, and it is necessary to establish an account with the vendor. Each vendor can be contacted by telephone, mail, fax, or e-mail, for more detailed instructions on how to access their services. Some vendors have their own communications network, and might have several different pricing options available for accessing their system. More and more of the commercial vendors are now offering registered subscribers access to their services through their home page on the Internet.

Costs for accessing commercial databases vary, both between vendors, and also between databases. Often the cost of using a database is based on a combination of how long one is connected to the database, and how many items one looks at. For example, to access PAIS International through DIALOG, based on January 1996 prices, it costs \$30.00 (\$US) per hour to be connected to the database, and to look at the bibliographic records, it costs an addition \$0.80 (\$US) per record. Other services offer what is often referred to as "flat fee" pricing, whereby the user commits to an agreed upon amount to use the vendor's databases. Regardless of the subscription option chosen, in addition to the costs of purchasing the necessary computer, modem and communications software, there will generally be costs involved for the use of the telephone lines to connect to the commercial vendor.

To use CD-ROMs, it is necessary to have a computer and a CD-ROM reader. A CD-ROM session is done locally: the user selects the appropriate disk, puts it into his or her local computer CD-ROM reader (if the user is part of a local area network, then the CD-ROM reader may not actually reside on the user's work station), enters a search statement, and receives a list of relevant database records. In this case, unlike the online databases, the CD-ROM database is purchased outright, and is retained by the user. The price of the CD-ROM is therefore not dependant upon the number of times the purchaser might use the CD-ROM. Prices for CD-ROMs vary greatly, but generally, CD-ROMs that are updated frequently and are sold as subscriptions, are more expensive than those that are never, or seldom updated. For example, based on January 1996 prices, to purchase the Middle East Diary on CD-ROM (which is not sold as a subscription), would be \$19.95 (\$US). To purchase Jane's Defence Weekly as a CD-ROM, (which is updated monthly), would be \$600 (\$US) for an annual subscription. System requirements for CD-ROMs vary, so it is best to contact the vendor for more information on specific products. Hardware costs include a computer and a CD-ROM reader. Since this system is housed on an individual's computer, there are no telecommunications charges.

THE INTERNET:

Setting up a connection to the Internet depends largely on the user's current computer system environment. If the user is part of a larger organization that has an established local area computer network, he or she should approach the system administrator to request Internet access.

If the user wishes to obtain access as an individual, at home or as part of a smaller organization, the following components are required: a computer, a modem (14400 baud or higher), communications software (e.g. Procomm, Telix, etc.), and a browser (e.g. Netscape, Mosaic, etc). The choice of browser will place restrictions on the hardware and software configuration of the user's computer. If the user wishes to run Netscape, for example, it will be necessary to have MS Windows version 3.1 or higher which, in turn, requires that the computer processor be a 386 or higher.

After acquiring the necessary computer components, the next step is identifying an Internet service provider in the user's geographical area. A commercial provider sells Internet access much like a telephone company sells telephone access. Fees are billed monthly or annually. A regional network provider may also allow the user to obtain access to the Internet. Whomever is chosen as an Internet provider, they will usually assist the user in setting up a connection. Typically, they will be able to provide all of the necessary software (communication and browser) in a single package, along with instructions on how to install it on the user's computer.

To summarize cost factors, in addition to the purchase of a computer, modem and software, there will also be on-going charges from the Internet provider depending on usage. Typically, there is a monthly base fee. For example, 50 hours of connect time monthly might cost \$20.00 (\$CDN) per month, and any additional connect time used would be charged at a separate rate, for example \$00.50 per hour. Additional fees are charged for any special services provided, for example personal home page creation and storage.
