First Halifax Rifles.

At a meeting of the above Company, held on Tuesday evening, 22nd April, 1879, the following Bye-Laws for the use of the Company were unanimously passed :

CO. D.

1. Shall be called the "First Halifax Rifles." Any person wishing to become a member of this Company, shall hand in his name to the Secretary, in order to have it submitted to the Committee of Investigation, previous to being ballotted for.

2. Every member of the Company shall contribute out of the annual grant, the sum of two dollars, as dues, to defray the ordinary expenses of the Company. All bills contracted in the name of the Company shall be submitted and approved of at a regular meeting, before being paid.

3. The Company shall annually elect a Treasurer, who shall take charge of all funds and property of the Company, and shall submit at each Quarterly meeting a statement of the receipts and disbursements.

4. All arrears by members shall be deducted from the annual grant allowed by the Dominion Government.

5. A quarterly meeting of the Company will be held on the first Tuesday in Janu-

try, April, July, and October. The annual meeting will be held on the first Tuesday in April.

6. Any member absenting himself from four consecutive drills of the Company, shall be debarred from voting at any meeting. Any member absenting himself from two consecutive full dress parades, without giving due notice, and cause thereof to Commanding Officer shall be dismissed from the Company. Any non commissioned officer absenting himself from four consecutive drills, without a reasonable excuse forwarded to the officer commanding the Company, shall be deprived of his rank.

6.7. Any member attending a parade or meeting of the Company in a state of intoxication, shall be immediately expelled.

8. A Committee of Investigation shall be appointed, to consist of seven members, four of whom shall be competent to transact business.

9. The Company shall be divided into three Squads, each in charge of a Sergt. and Corporal, whose duty it shall be to notify the men of each Squad of all meetings and parades of the Company.

10. A Secretary shall be appointed to serve during pleasure. He shall keep a correct record of all meetings and parades of the Company, collect all dues, and pay them over to the Treasurer, taking his receipt therefor.

22. No officer of the Company shall be allowed to compete for Company prize at annual firing.
