THE ARABS AND GERMANS.

Portulacas of the Battle of Baginoyne. BY TELEGRAPH TO THE GAZETTE.

ZANZIBAR, March 6.—The fighting at Baginoyne on Sunday was severe. The Arabs attacked the German landing parties with fury, meeting them on the water edge to meet them and occupying the shore at every point where a landing could be effected.

They were driven off by a combined line of men-of-war and sailors and marines who also behaved with steadiness, in face of vastly superior numbers. The Arab loss was heavy. They left a number of dead on the shore and carried off a good many more. They fled as soon as their chief losses were recorded. The Germans recaptured two canoes which had been taken by the natives in a former fight. The Germans are strongly interested at Baginoyne. They will hold the place permanently to prepare a way for Capt. Wiseman's expedition to the other islands.

PROUD OF UNION. JUSTICE GREAT SPEAKS THE WORDS OF PATRIOTISM. BANQUET OF THE VANCOUVER BOARD OF TRADE.

(BY TELEGRAPH TO THE GAZETTE.) VANCOUVER, March 6.—The first annual banquet of the Vancouver Board of Trade last night was an unqualified success. About 120 all sat down to a sumptuous repast in the hotel Vancouver and neither music, flowers nor decorations were wanted to heighten the effect. The patriotic toasts were given by several members of the legislature, the provincial assembly, officers of the city and municipalities, officers of the other boards of trade were present.

The small loyal and patriotic toasts were very honored and the host of the banquet, Mr. Justice Gray in responding to the toast of the Board of Trade, said that the Board of Trade is a direct and most satisfactory representation of the province and that the various trades connected with it are all doing well. He predicted that the next year would show that British Columbia had made more and more strides in the last few years. The toast was not exhausted till 11 o'clock this morning.
