THIS MORNING'S DESPATCHES Great Earthquake in the City - of Lahore.

Five Hundred Lives Lost.

Animals Swallowed Up.

Fleeing to the Mountains.

Fatal Accident in Louisville.

Fearful Snow Storm in California.

Calcutta, Feb. 4.—An earthquake has occurred at the city of Lahore, in the territory of Scinde, which was attended by heavy destruction of human life. The disaster overtook the city so suddenly and unexpectedly, that no escape was possible. On the first alarm the inhabitants rushed from their houses into the streets, where many met their death from falling buildings; while those who dispised the warning, and remained with-in, were in many instances buried among the ruins of their own dwellings. It is estimated that upwards of five hundred persons perished thy the calamity. A large number of animals were swallowed up by the earthquake. A great part of the city is now in ruins. The earthquake extended over a large tract of country. being distinctly felt at towns many miles distant from Lahore. The inhabitants of Lahore, after the first convulsion was over, seized their moyeables and fiel to the mountains. 



The Heraid attempts, but com pletely fails, to exonerate Mr. Chad-wick from the charge we preferred against him, of having obtained the County printing by a mean evasion of the statute disqualifying him or any other member of the County Council from holding a contract un-der it. But, in order to withdraw public attention from the iniquity and illegality of his course in this matter, we are treated to even more than the ordinary string of falsehoods, misrepresentations, jesuitical eva-sions of the truth, and skilful dodg-ing of the real question at issue. Having already given the facts of the case, which the Heraid has not, and dares not deny, as well as our candid opinion of Mr. Chadwick's conduct, which throws disgrace and discredit on him as public servant, we do not intend to occupy more of our space on the subject than is sufficient to repel the unfounded and malicious charges which the Heraid brings against the Mszerwar in connection with this matter of County printing. In the first place, it charges that we have had a monopoly of the County printing. This is utterly un-true. We obtained it for several years consecutively by fair and square competition, just as the Heraid some ten or twilve years ago obtained it, and held it for a number of years. If it was a monopoly in the one case it was a monopoly of the printing he states what he knows this well enough, and when he says that we have had a monopoly of the printing he states what he knows to be false, though he has not manliness enough to admit it. Again, in saying that this printing was given to us year by year 'by a few of the Grits in the County' he wantonly impugns the honesity and maligns. the character of such statunch Conservatives as the present Warden and County Clerk, the late Warden, Mr. Lesile, and the late Clerk, Mr. Ferrier, who are or were members of the Printing Committee, and who year after year accepted our tender as the lowest. Are these "the Grits who manipulate the public purse for the benefit of their friends?" No the Heraid s

We consider it unneces-sary further to notice the reckless assertions of such an unscrupulous and dishonest writer, who regards neuther truth nor honor nor honesty. We dismiss the subject by repeating our former assertion, that Mr. Chad-wick in this matter has been guilty of a mean evision of the law, which no pfre-minded public servant, or high-toned gentleman, who is care-ful of his public character, would have stooped to, and we do not hesitate to say that nime tenths of the people, whether Reform or Conservative, are of the same opinion.

The Intercolonial and Pacific Railways The Intercolonial Railway Commi sioners met at Ottawa on Tnesday. The

sioners met at Ottawa on Theeday. The contractors on that line are largely re-presented; one or two are putting in their final estimates, having completed their work. The greater number of them, however, are bosciping the Commissioners with large elams for extras. It is esti-mated that the extres claimed will amount to nearly five millions of dollars, one firm alone domanding half a million. This latter firm belongs to Quebee, and its members were active supporters of Mr. Langevin at a recent cletchion in Que-bee eity; and broad hints are given by some, who should have the means of knowing the circumstances, that their claim for extras would not have beer nearly so large but for the necessity of reinbursing the substantial advances frade on account of election expenses. It is said that the Opmissioners are apal-led at the magnitude of the cleims thus put in, and have resolved to shirk the responsibility by handing the whole mat-ter of the extras over to be dealt with by the House. The leading contractors brought hither by the Welland Canal and Intercolonial Railway works are turning their attention towards the Pacific Rail-way. A combination, which will include A. P. Maedonald, Donald Robertson, Jaures Ross, Durcen McDonald, Alex, Maedonald, and several others, have now contractors on that line are largely re-
