

BILL.

An Act to incorporate La Communauté des Filles de Ste. Anne, of the parish of St. Jacques de l'Achigan, District of Joliette, for the purposes of Education.

WHEREAS an Association of Religious Ladies hath existed for Premble. W several years in the parish of St. Jacques de l'Achigan, County of Montcalm, District of Joliette, under the name of "La Communauté des Filles de Ste. Anne," for the instruction and education of 5 children, and hath imparted instruction and education to a great numher of young persons at very moderate rates; and whereas the said Religious Ladies have by their petition prayed that the said Association may be incorperated, and in consideration of the great benefits which must arise from the institution, it is expedient to grant their 10 prayer : There fore, Her Majesty, &c., enacts as follows :

I. Marie de la Purification, by birth Eléonore Pivin ; Marie de la Nativité, by birth Salomée Veronneau ; Marie Jeanne, by birth Angèle Giroux ; Marie Alphonse, by birth Catherine Béfort ; Marie de la Providence, by birth Hélène Tucker ; Marie Stanislas, by birth Sophie

- 15 Saintonge; Marie de la Garde, by birth Adélaide Ledoux, and such other persons as shall under the provisions of this Act, become members of the said institution, shall be, and are hereby declared to be a body politic and corporate, in deed and in name, by the name of La Corporate Communauté des Filles de Sainte Anne, and by that name shall have
- 20 perpetual succession and a common seal, and shall have power from time to time to alter, renew or change such common seal at their pleasure, and shall by the same name, from time to time and at all times hereafter, be able and capable to purchase, acquire, hold, possess and enjoy, and to have, take and receive, to them, and their successors, to and for the
- 25 uses and purposes of the said corporation any lands, tenements, and hereditaments, and real or immoveable property and estate, within this Province, not exceeding in yearly value the sum of thousand pounds currency; and the same to hypothecate, sell, alienate and dispose of, and to purchase others in their stead, for the same purpose; and
- 30 by the said name may sue and be sued, implead and be impleaded, answer and be answered unto, in all Courts of Law and places whatever, in as large, ample and beneficial a manner as any other body politic or corporate, or as any persons may, in any way whatsoever, lawfully, do and any majority of the members of the Corporation for the time being,
- 35 shall have full power and authority to make and establish such rules, orders and regulations, not being contrary to this Act, nor to the laws Lawe. in force in this Province as shall be deemed useful or necessary for the interests of the said Corporation, and for the management thereof, and for the admission of members into the said Corporation, and from time
- 40 to time, to alter, repeal and change the said rules, orders and regulations, or any of them, or those of the said institution in force at the time of the passing of this Act; and shall and may do, execute and per- Farther powform all and singular, other the matters and things relating to the said ere-

Corporation, and the management thereof, or which shall or may appertain thereto, subject, nevertheless, to the Rules, Regulations, stipululations and provisions hereinafter prescribed and established.

II. Provided always, That the rents, revenues, issues and profits of all property, real or personal, held by the said Corporation shall be appropriated and applied solely to the maintenance of the Corporation, the construction and repair of the buildings requisite for the purposes of the said Corporation, and the payment of the expenses to be incurred for objects legitimately connected with or depending on the purposes aforesaid. 10

III. That all and every the estate and property, real and personal, belonging to or hereafter to be acquired by the Members of the said Association as such, and all debts, claims and rights whatsoever, due to them in that quality, shall be and are hereby vested in the Corporation hereby established; and the Rules, Orders and Regulations now made 15 or to be made for the management of the said Association, shall be and continue to be the Rules, Orders and Regulations of the said Corporation until altered or repealed in the manner herein provided.

IV. The members of the said Corporation for the time being, or a majority of the administrative body thereof, shall have power to appoint 20 Attorneys or Administrators of the affairs and of the property of the Corporation; and all Officers so appointed shall be capable of exercising such other powers and authority for the well governing and ordering of the affairs of the said Corporation as shall be prescribed by the Rules, Orders and Regulations of the said Corporation. 25

V. Nothing herein contained shall have the effect or be construed to have the effect of rendering all or any of the said several persons herein before-mentioned, or all or any of the members of the said Corporation, or any person whatsoever, individually, liable or accountable for any debt of the said Corporation, or in respect of any contract or 30 security incurred for and in the name of the said Corporation, or in respectof any matter or thing whatsoever relating to the said Corporation.

Saving of Her Majosity's Rights, &c. Nothing herein shall affect or to be construed to affect, in any manner or way, the rights of Her Majesty, Heirs or Successors, or of any person or persons, or of any body politic or corporate, such only 35 excepted as are hereinbefore mentioned and provided for.
