



BROTHER NOW UNDER ARREST

Notorious Criminal Arrested in Seattle at Instance of Provincial Authorities.

MUST FACE OLD CHARGES

Pardoned Man Writes Some Letters to Authorities in Vancouver.

DESIRES BROTHER, the notorious procurator who was released by the federal government after serving two years of a term of seven years imprisonment for perjury and procuration, was arrested at Seattle yesterday afternoon at the instance of the British Columbia government.

He will be brought back to Vancouver, where public opinion was outraged so flagrantly by the action of the department of justice at Ottawa, and will be placed on trial for forgery and theft charges upon which a stay of proceedings was entered when he was convicted of procuration and perjury and sent to prison to serve the term of imprisonment from which he was released.

Secure the Arrest of the subject of the inexplicable As reported, the superintendent of provincial police, F. S. Hussey, was instructed some days ago by the attorney-general, Hon. Mr. Pugh, to arrest Brother, who was believed then to be in Montreal on his way to France.

He had agreed to return to France when pardoned by the Dominion government by the Allan liner Virginian. Mr. Hussey wired to Montreal and Quebec and had the Vancouver police forward descriptions of Brother to the eastern police to arrest him.

Despatches were received stating that he had not left by the Virginian, and it was then feared that he had escaped justice and had left for France by the steamer La Lorraine, running direct from New York for Havre. On Monday Superintendent Hussey learned that his quarry was in Seattle, where he had gone by the steamer Ramona after being freed, not intending to keep the promise made to return to France.

Soon after Superintendent Hussey had communicated with the Seattle police he received a telephone message from provincial police officers at Vancouver stating that:

Brother Had Written Letters to Vancouver newspapers and to the mayor of Vancouver, stating that he was in Seattle and had defied arrest. Superintendent Hussey then wired Chief of Police Wapensteyn of Seattle asking him to arrest Brother. Yesterday afternoon a despatch was received from the Seattle chief stating that he had arrested Brother from the notorious convict.

W. J. Bowser, M. P. P., of Vancouver, who is now in this city, whose firm was instrumental in seeking to bring the notorious man back to the province, was freed by the Ottawa government, was asked by a Colonist reporter last night what steps would be taken to secure the return of Brother from Seattle. He said the United States immigration authorities had agreed to deport Brother, who was an undesirable immigrant.

In the meantime Brother was being held, locked up, by the Seattle police at the instance of the British Columbia government. The return might be delayed for some days, as it is understood delay may be caused awaiting the arrival of a warrant from Washington ordering the deportation of the released criminal.

Fought for New Trial Seattle, Wash. 8 of June, 1906. To His Worship the Mayor of Vancouver.

Sir—I have the honor to inform you that I am at the disposal of the Vancouver Justice. I am only too glad to take the opportunity of exonerating myself, not only of the charges which I am accused of, but also for those for which I was sentenced to be sent to jail and penitentiary to be produced.

From the moment I was tried and before sentence was passed upon me until February last, I have begged and fought hard for a new trial. I am glad to expose that the court and the jury had been misled by a clique to assure my conviction, benefiting thereby of many thousand dollars taken from me under false pretences in a moment of temporary insanity. I have been led to believe that the pardon granted me by the honorable minister of justice was on condition of leaving the country forthwith, but I denied the proofs of such conditions when I asked them to be produced.

I admit that when I was made aware that I had to leave the country I refused to finish my time in Seattle accept the conditions, I signed a letter sent me the 26th of April, whereby I proposed to go to France immediately if released.

I signed that letter because I believed that such conditions could not be enforced in a free civilized country. I signed that letter when I had found out that there was no other means but my release to help me to secure my rehabilitations and my rights.

I objected and stayed in Vancouver, I consulted legal talent to get redress for the wrongs done to me. Then I decided to come and remain in Seattle until I secured all the necessary evidences to proceed further. Then the news of my being in Seattle, and the cowardly feeling the consequences that may follow, waited until they were sure that I was out of the country to resort to the press in order to produce the public opinion against me and to urge a bluff, to keep me out of the country.

Today they can bluff me no more. They can fool me no more. I am able to make myself understood in English. I am entitled to a hearing in court in which my rights are at stake. I hereby promise that I will not take the assistance of no lawyers, and if you upheld the principles of justice as you pretend to you will do your best to have me in court again, according to my wishes expressed in an open letter sent yesterday to His Worship Mayor Buscombe. I had not read your paper yet when I sent said letter.

UNIFORM PASSENGER RATE.

Bill Introduced at Washington Provides for Two-Cent-a-Mile Rate. Washington, June 12.—Representative Sherman of New York, introduced a bill today providing that the passenger rate on all railroads in the United States should be two cents a mile, effective January 1st next. A uniform system of mileage books is provided for, which should be used by all passenger trains. The bill is referred to the committee on foreign and interstate commerce, of which Mr. Sherman is the ranking republican member.

HERO OF SHATTERED TUBE.

New York Foreman Saves Men From Death. New York, June 12.—Following a blast of rock today in one of the tubes of the Battery tunnel, a "blowout" occurred that filled part of the bore with water and mud and nearly engulfed 13 workmen. The accident was in the south tube leading out from the Brooklyn side at the foot of Joralemon street, about 500 feet from the shore. The tunnel is to form the connecting link between the subway systems of Manhattan and Brooklyn. The cool-headed foreman saved the men from a panic among them and marched them safely into the air locks. He closed the doors to stop the flood and finally brought all his men to the surface.

DR. MARY PUTNAM DEAD.

Well Known Scientific Writer Dies After Protracted Illness. New York, June 12.—Dr. Mary Putnam Jacobi, who was the wife of Dr. Abraham Jacobi, and was a distinguished specialist in children's and nervous diseases, died at her home in New York city, after a long illness, at one time an ardent woman suffragist, died on Sunday at her home here. Her death extended over a period of four years.

Mrs. Jacobi married Dr. Jacobi in 1876. At that time she was recognized as one of the most progressive and intellectual women of her time, particularly in medicine. She was the first woman to be admitted to the Ecole de Medecine in Paris and was second to get a diploma from that institution. She was also the first woman to make it to the New York academy of medicine. She was born in London in August, 1842. Her father was George Palmer Putnam and her mother the publisher's house of that name.

Toronto Clergyman Dead. Toronto, June 13.—Rev. Joshua Pitt Rivers, rector of Grace Church, died suddenly this morning from an attack of acute indigestion affecting the heart.

Fatal Cycling Collision. St. Thomas, June 13.—Hiram Dent, car inspector of the Pere Marquette Railway, while commuting on his bicycle, was killed by another bicyclist, sustaining injuries which will probably prove fatal.
